Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014

109 Functions and powers

- (1) The Maunga Authority has the powers and functions conferred on it by or under this Act or any other enactment.
- (2) In exercising its powers and carrying out its functions in relation to the maunga, the Maunga Authority must have regard to—
- (a) the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau; and
- (b) section 41(2).
- (3) In exercising its powers and carrying out its functions in relation to the administered lands, the Maunga Authority must have regard to the spiritual, ancestral, cultural, customary, and historical significance of the administered lands to Ngā Mana Whenua o Tāmaki Makaurau.

[Emphasis added]

41 Maunga must remain as reserves vested in trustee

- (1) This section applies to each maunga once the maunga is—
- (a) vested in the trustee under subpart 1, 2, or 3 of this Part;

and

- (b) Declared a reserve under any of sections 18 to 29, 33, and 39.
- (2) The maunga is held by the trustee for the common benefit of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

Deferred from 16 September 2024 - Removal of Tūpuna Maunga from Schedule 2 – Auckland Council Policy on Dogs 2019

Purpose	To consider whether to recommend removal all Tūpuna Maunga from Schedule 2 of the Auckland Council Policy on Dogs 2019.
Recommendation	 That the Tūpuna Maunga o Tāmaki Makaurau Authority: a) requests management to make a submission to the Auckland Council on its review of the Auckland Council Policy of Dogs 2019 seeking the removal of all Tūpuna Maunga from Schedule 2 of that policy.

Background

- 1. The Dog Control Act (DCA) 1996 requires Auckland Council to have a policy on dogs and a bylaw to implement the policy.
- 2. The Auckland Council Policy on Dogs 2019 (Policy on Dogs) came into force on 1 November 2019 with the main objective being to keep dogs as a positive part of the life of Aucklanders by:
 - a. Maintaining opportunities for owners to take their dogs into public places
 - b. Adopting measures to minimise the problems caused by dogs
 - c. Protecting dogs from harm and ensuring their welfare.
- 3. The Auckland Council bylaw must be reviewed in 2024 to determine if it is still appropriate having regard to a number of matters including:
 - a. The need to minimise danger, distress, and nuisance to the community generally.
- 4. Whilst the Policy on Dogs does not expire, this policy will be included in the review process. The policy includes general dog access rules in public spaces as well as designated dog access rules, which impacts 4 Maunga.

Statutory and other considerations

- 5. The process and any decision to adopt an Operational Plan, and summary thereof, is required to take into account the legislative and policy framework.
- 6. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 7. The Tūpuna Maunga Authority's Integrated Management Plan was unanimously adopted (Mana Whenua and Auckland Council members) by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.

- 8. The Tūpuna Maunga Authority (Mana Whenua and Auckland Council members) unanimously adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 9. The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 sets out a process for the adoption of an "Annual Operational Plan" by the Authority (refer sections 60-63). Management have worked alongside the council's legal and finance teams to ensure compliance with the procedures set out in the legislation.
- 10. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

Discussion

Current Dog Access on the Maunga

Schedule Definitions in the Auckland Council Policy

- 11. The Policy on Dogs includes two schedules that relate to dog access rules, these being Schedule 1 and Schedule 2.
- 12. Schedule 2 refers to dog access rules in defined locations which are under decision making control of Auckland Council. Currently there are 3 Maunga and two designated areas on Maungawhau that are defined as Schedule 2 sites.
 - Ōwairaka /Te Ahi-kā-a-Rakataura/Mount Albert.
 - Takarunga/Mount Victoria.
 - Te Tātua-a-Riukiuta/Big King.
 - Maungawhau Domain: the fenced paddock between Clive Rd entrance and Summit Rd.
 - Tahaki Reserve: north-east of the bowl demarcated by the bush and pathway,
- 13. Schedule 1 in the Policy on Dogs relates to general dog access rules. The remaining Tūpuna Maunga are subject to Schedule 1 default dog access rules (clause (c) to (d)).
- 14. See attachment A for current dog access rules on the Maunga.

Current Decision-Making Authority on the Maunga

Schedule 2 Decision-Maker

15. The Maunga and included areas listed above are all specifically mentioned in Schedule 2. This means that the decision-maker regarding dog access rules in these areas is Auckland Council. Management recommend it is the Tūpuna Maunga Authority that should have the authority to set policy positions (as provided for in Schedule 1).

Schedule 1 Decision-Maker

16. Any Maunga that are not specifically listed in Schedule 2 are under the decision-making authority of the Tūpuna Maunga Authority.

Recommending the Transfer Decision-Making Authority

Auckland Council review of Policy on Dogs 2019

- 17. The Authority has an opportunity to request that through the review process, Auckland Council reclassify all Schedule 2 Maunga and areas to Schedule 1. This would ensure that the Authority has the future ability to make dog access policy decisions on every Maunga.
- 18. All current dog access rules would remain the same if the schedule change was implemented after review, until such a time as the Authority may deem it necessary to change policy position.
- 19. The approximate timeline for this Council review process includes the following:
 - a. Seeking local board feedback on the draft proposal in October,
 - b. The Regulatory and Community Safety Committee recommends a proposal to the Governing Body to adopt for public consultation in December.
 - c. Public consultation is scheduled for January/February 2025.
 - d. Final decision is expected to be made in July 2025.

Purpose	To consider a concept design for the reinstatement of the neighbourhood playground at Ōtāhuhu / Mount Richmond.			
Recommendation	 That the Tūpuna Maunga o Tāmaki Makaurau Authority: a) approve the replacement of the neighbourhood playground at Ōtāhuhu / Mount Richmond in accordance with Attachment A to this report. 			

Background

- The Auckland Storm events in early 2023 resulted in a large tree falling over and destroying the existing neighbourhood playground at Ōtāhuhu/Mt Richmond. This event has provided the opportunity not only for the Tūpuna Maunga Authority to look at future play opportunities for the Maunga but also to investigate ways to enhance the mauri of the Maunga, improve the visitor experience, and increase community understanding of and respect for the Maunga.
- 2. The site location is as below.



Statutory and other considerations

- 3. Any decision to determine management within a reserve must take into account the legislative and policy framework.
- 4. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also relevant. The activities of the Scouts are consistent with the reserve classification.

- 5. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 6. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.
- 7. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.

Discussion

Reporepo Proposal

- 8. The Authority has considered this project at Hui 91 (29 April 2024) and Hui 93 (29 July 2024). The concept presented as Attachment A incorporates the Authority's feedback from those hui. The concept of Reporepo is based on traditional hīnaki (eel trap). Key play feature takes the form of a hīnaki (eel trap) acknowledging the wetland basin that was once a source of kai and mahinga kai. Play experiences include swinging, climbing, rocking, wheeled play, imaginative play, sensory nature play. This concept utilises New Zealand manufactured play elements.
- 9. In relation to interpretative signage, this element will be progressed through a separate project which will look at signage across the Maunga including the playground.

Next Steps

10. With the approval of the Stage 1 Tākaro Concept, the Team will proceed to procurement and implementation. The Team is working towards having the playground reinstated in Summer 2025.



Takarunga courts & bus parking development

Purpose	To consider concepts for visitor improvements to the courts and bus parking at Takarunga – Mt Victoria.				
Recommendation	That the Tūpuna Maunga o Tāmaki Makaurau Authority:				
	a) approve proceeding with the proposed court upgrade and bus parking improvements as set out in the report and plans attached.				

Background

- 1. The scope of the project consists of the upgrade of the existing tennis courts to improve the recreation value, and provision of a dedicated bus parking and drop-off area.
- The Authority previously considered the courts upgrade project at Hui 63 (19 April 2021), and Hui 65 (26 July 2021) at Hui 89 (12 February 2024). The bus parking was first considered at Hui 66 (23 August 2021). The project was most recently considered at Hui 94 (16 September 2021)
- 3. The key drivers for this piece of work are:
 - a. A need for wharepaku to cater for visitors.
 - b. The deterioration of the court surface, fences and furniture
 - c. Direction from the Integrated Management Plan.
 - d. Improved active and passive recreation provision.

Statutory and other considerations

- 4. Any decision to determine management within a reserve must take into account the legislative and policy framework.
- 5. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 6. The Tūpuna Maunga Authority's Integrated Management Plan was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.
- 7. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 8. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

Discussion

Design summary

9. The developed designs for the courts and bus drop-off area are presented in Attachment A. The concepts include representations of the artworks developed by Arapeta Hakura.

Courts area

- 10. The recreation value of the courts is increased by incorporating passive as well as active recreation elements. This includes a multi-purpose court, a rear activation/games wall, accessible park furniture, an accessible toilet, and two entry points. The sporting code combination for the court was decided due to the community ties to tennis, and basketball due to the courts' historic use and the current popularity among young people of the sport.
- 11. The plan shows informal natural play such as rock/log/rope/balancing elements located in the raised garden bed to create a mini nature trail. In addition to this there is a dedicated informal play zone located within the court area. This consists of colourful mulched rubber (recycled) mounds designed in a 'v' formation which represents both migratory birds and waka navigation. Spheres of varying sizes will provide jumping/seating play value. The rubber safety surfacing is required to meet compliance in absorbing shock.
- 12. The court surface has been designed as concrete for practicality reasons. Surface water drainage will utilise the gardens where possible to ensure filtration of stormwater runoff.
- 13. Management are continuing to investigate options to place a single accessible carpark nearby.

Bus drop-off

14. The design presents a bus drop-off area in an extension to the 3 existing carparks located north-west of the Devonport Primary School. The road will need to be widened to the existing bollards to ensure manoeuvrability of buses. Boxed steps will facilitate safe pedestrian access to the tihi road. This option was selected due to it being the least imposing in terms of built form, low archaeological and environmental impact, and modest whole-of-life costs. Decorative paving panels in the road will emphasise the shared nature of the space with an emphasis on pedestrian priority.

<u>Mahi toi</u>

- 15. The narratives represented in patterning on the court surface and rear games wall, bus parking zone, furniture, whariki (welcome mats), and pou pay homage to the importance of Takarunga, connecting it to the broader narratives of migration, exploration, and the intertwined destinies of people who followed their paths to Aotearoa.
- 16. Referencing the legacies of the Tainui waka, a scuplural piece inspired by waka maumahara is included in the elevated position approaching the main road to the tihi.
- 17. The concept is supported by native planting appropriate to the Maunga in extended areas on the court boundaries and includes species that were once prevalent across the Maunga such as Puriri, Taraire and Kohekohe.
- 18. Archaeologists and heritage experts have been involved in the development of the courts plans and the drop-off zone plans and will continue to be involved as the designs are further developed.

Next steps

19. Management will progress the designs with a view to the procurement of physical works.

1. Waka Maumahara Design Development

One waka maumahara inspired sculpture is proposed. The proposed location is shown on the following sheet, on the right hand side of the road approaching the bus parking area. This location is open, elevated and has good sight lines.

The sculpture explores the legacies of Tainui Waka. Its forms are based on the breaking of waves on a waka during travel. These waves have been transformed into 3D loops, joined to create monuments that re-imagine what a waka can be.

Possible material options include perspex or steel.

'Pushing how we think about waka in contemporary art opens up conversations around structure, form, interpretation, meaning, and feeling. These sculptures aim to evoke a sense of travel, time, water, people, and movement. The form itself reflects elements of a waka, like the taura (rope) and other essential parts. By using a contemporary lens, the work not only reinterprets the waka but also connects deeply to the histories and stories tied to it, while bringing those elements into the present."



 That the Tūpuna Maunga o Tāmaki Makaurau Authority: a) delegate to the Chair and Deputy Chair the power to execute a lease, including a Maunga Outcomes Plan, with the Takarunga Playcentre for the term of Five (5) years at a market rental (as determined by a registered valuer) and otherwise on the standard terms and conditions; and b) delegate to the Chair and Deputy Chair the power to agree to terms governing the termination arrangements of the Takarunga Playcentre should the Playcentre decide not to accept the new 			

Background

- 1. The Takarunga Playcentre (the Playcentre) lease was inherited by the Tūpuna Maunga Authority. This lease was originally with the North Shore City Council (predecessor to Auckland Council) and was drafted in accordance with that council's policy at the time.
- 2. At Hui 79 (12 September 2022) the Tupuna Maunga Authority resolved to grant a new lease to the Takarunga Playcentre for initial term of 1 year ending 31 August 2024.
- 3. The Playcentre occupies an area of Takarunga/Mount Victoria which is classified as a Local Purpose Reserve. The location of the lease area is shown in Attachment A.
- 4. The Playcentre owns and maintains the building that they currently occupy.

Statutory and other considerations

- 5. Any decision to determine management within a reserve must take into account the legislative and policy framework.
- The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also relevant.
- 7. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the tūpuna maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 8. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.

- 9. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 10. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.
- 11. The activities of the Playcentre are otherwise consistent with the reserve classification. There have been no other parties who have expressed an interest in occupying the site

Discussion

Leases on Tūpuna Maunga

- 12. The Tūpuna Maunga o Tāmaki Makaurau Integrated Management Plan (IMP) describes a series of values and pathways that dictate decision-making on leases. The IMP places the health and well-being of the Tūpuna Maunga at the heart of all decisions.
- 13. Any leasing activity must be consistent with the IMP Tūpuna Maunga values and should actively promote those values.

Playcentre

- 14. Playcentre is an early childhood education and parenting organisation which operates parentled early childhood education centres throughout New Zealand. Each Playcentre is cooperatively managed by parents and supported by Te Whānau Tupu Ngātahi o Aotearoa -Playcentre Aotearoa. Its philosophy is that parents are the first educators of children and it encourages the involvement of whānau in early childhood education.
- 15. The statistics for this centre fluctuate seasonally. The centre currently has 30 Tamariki enrolled with most going to 2 or more sessions per week. Session days and times are Monday, Wednesday and Friday 9am 12.30. There are 35 registered caregivers and range from mothers, fathers and grandparents. Two whānau that Identify as Māori lead kawa and tikanga for the centre.
- 16. Maunga Outcomes plan:
 - Regular hikoi with Tamariki to the tihi
 - Demonstrated Mātauranga Māori tikanga, kai karakia, karakia during renewal works, learning Māori waiata and displaying kupu on walls. They have listened to feedback from local rangatira and adjusted the tikanga accordingly.
 - Mātariki celebration for over 8 years
 - Regular Pest control and external compliance checks
 - Changed centre name from Northshore Playcentre.

Terms

<u>Term</u>

17. Management has a good working relationship with the tenant. Takarunga Playcentre has completed their Maunga Outcomes plan demonstrated their contribution to the wellbeing of the Maunga and the values set out in the IMP.

18. Given the above context management recommend a term of 5 years.

<u>Rental</u>

19. Rental assessment has been done by the registered valuer in 2022 at \$6,060 per annum. Management will seek advice from a registered valuer to assess the market rental at the beginning of the lease and at periodic terms during the lease.

Next Steps

20. If a lease is to be offered, Management will work alongside the Playcentre to draft a Tūpuna Maunga Lease for consideration and execution by the Chair and Deputy Chair.

Background

- The previous Onehunga Mangere United Sports Club (the Club) lease was inherited by the Tūpuna Maunga Authority. This lease was originally with the Manukau City Council (predecessor to Auckland Council) and was drafted in accordance with that council's policy at the time.
- 2. At Hui 66 (23 August 2021) the Tupuna Maunga Authority resolved to grant a lease to the Onehunga Māngere United Sports Club for the initial term of 1 year plus 1 year renewal with the final expiry ending 31 August 2023.
- The Club occupies an area of Te Pane o Mataoho / Te Ara Pueru / Māngere Mountain which is classified as a Recreation Reserve. The proposed lease area is shown in red of the Attachment A.




Figure 2: Proposed Leased Area, noting the publicly accessible amenity block on the ground floor does not form part of the proposed lease area.

- 4. The lease area covers the building on the site, excluding the ground floor amenity block as shown within the dotted line in Figure 2. The Club owns the portion of the building that they occupy.

Statutory and other considerations

- 5. This paper updates the Authority on an area of Te Pane o Mataoho / Te Ara Pueru / Māngere Mountain under lease to the Onehunga Mangere United Sports Club. The location of the current leased area is shown below in Schedule A.

- 14. Any leasing activity must be consistent with the IMP Tūpuna Maunga values and should actively promote those values. One step is a Maunga Outcomes Plan which forms part of all leases on Tūpuna Maunga.

Sports Club

- 15. Originally, Club had union of Football and Softball. Softball has recently decided to reallocate to a new location. Football division has 488 members this season. Member age groups are 58% Tamariki less than 12 years, 12% Tamariki 13 to 16 years and 30% Pakeke/Adults. Over 10% of members are Māori. Softball division had 116 members. Club is currently undergoing the winding up process and working with local kura on increasing membership for the football division.
- 16. Maunga Outcomes Plan
 - Recognise relationship of kura and working with local schools and our members encouraging diversity.
 - Monitor members of the public who might intend on harming the Maunga continuing our custodianship.
 - Club has implemented rodent and pest control program for several years now.
 - They ensure area is rubbish free.
 - Promote smoke free on Maunga and alcohol free on Maunga.
 - They are committed to promote Maunga at event introductions.
- 17. Management has recently granted permission to for the club to hire out club rooms for community events, fundraising events and training seminars/workshops. Subletting is not permitted.

Key Terms

<u>Term</u>

- 18. Onehunga M\u00e5ngere United Sports Club has completed their Maunga Outcomes plan demonstrated their contribution to the wellbeing of the Maunga and the values set out in the IMP. Lease is currently rolling over on month by month basis.
- 19. Given the above context management recommend a term of 5 years commencing on 1 November 2024.

<u>Rental</u>

20. Rental assessment has been done by the registered valuer in 2020 at \$3,400 per annum. Management will seek advice from a registered valuer to assess the market rental at the beginning of the lease and at periodic terms during the lease.

Next Steps

21. If a lease is to be offered, management will engage in public notification process.

Background

- Mt Wellington Roller Sports Club Inc (Skateland) provide a large indoor roller skating and sports rink and have been located on Maungarei since 1969. They have an existing legacy lease carried over from Auckland Council. It commenced on 1 January 2010 and was for an initial term of 5 years with two rights of renewal of 5 years each with a final expiry of 2024. Skateland owns the building and improvements.
- At Hui 50 (25 September 2019) the Tupuna Maunga Authority resolved to grant a renewal of lease to the Mt Wellington Roller Sports Club Inc for the last term of 5 years ending 31 December 2024.
- 3. At Hui 92 (20 May 2024) the Tupuna Maunga Authority resolved to public a new lease to the Mt Wellington Roller Sports Club Inc term of 5 years ending 31 December 2029.

- 4. No submissions have been received following the public notification process under under s119 of the Reserves Act 1977.
- 5. Following the decision in Hui 92 Skateland have requested further lease renewal for the term of 5 years to make their nearly \$100,000 investment into renewing the skate floor viable.
- 6. Skateland occupy an area of Maungarei / Mount Wellington which is classified as a Recreation Reserve. Skateland currently own and maintain the building they occupy. The location of the lease area is shown in Attachment A.

- 15. Section 53(1) of the Reserves Act allows the Authority to prescribe the games, sports and other activities for public recreation that may take place in any specified part of the Reserve. This section also allows the Authority to grant organisations exclusive use of parts of the reserve for a sporting or recreation purpose.

Leases on Tūpuna Maunga

- 16. The Tūpuna Maunga o Tāmaki Makaurau Integrated Management Plan (IMP) describes a series of values and pathways that dictate decision-making on leases. The IMP places the health and well-being of the Tūpuna Maunga at the heart of all decisions.
- 17. Any leasing activity must be consistent with the IMP Tūpuna Maunga values and should actively promote those values. One step is a Maunga Outcomes Plan which forms part of all leases on Tūpuna Maunga.
- 18. The Maunga Outcomes Plan sets out activities that the lessee will do to contribute to the health and well-being of the Tūpuna Maunga. The activities to be carried out by the lessees are co-designed by the lessees and Authority management and reflect the Tūpuna Maunga values. Scouts agrees to a series of measures within the Maunga Outcomes Plan that track progress.
- 19. The activities are consistent with the classification of the reserve. There have been no other parties who have expressed an interest in occupying the site.
- 20. The club has 312 members and in the last 12 months they hosted 31,285 skaters though public skate sessions. Skate attendance age groups are mainly 0-13 years with 34% Māori Tamariki. They operate 7 days/week: Mon-Sun are club (member sports/teams) bookings and Fri-Sun are public skate sessions.
- 21. Maunga Outcomes Plan
 - Skateland has created an end-of-session experience to raise public awareness of Maungarei.
 - Skateland were involved in planting on the Maunga.
 - The club manager regularly visits the Maunga and, since the closure, it has been very clean.
 - Skateland helped with the Guy Fawkes closure one year and were not needed the year after.
 - Looking ahead at new Maunga Outcomes, the club suggested that Skatelands help do up the sidewalks going up along the walkway.

Terms

<u>Term</u>

- 22. Skateland has been supporting all initiatives taken in Maungarei, they have demonstrated their contribution to health and wellbeing of the Maunga and have successfully formed a good working relationship with Management. Skateland is a bespoke building and there is no immediate need for the area or the building in the Individual Maunga plan.
- 23. Given the above context management recommend 5 year lease term commencing on 1 January 2025 with 5 years right of renewal and the final expiry date 31 December 2034.

Rental

24. Management will seek advice from a registered valuer to assess the market rental.

Next Steps

25. If a lease is to be offered, management will engage in public notification process.

Background

- 1. The Tūpuna Maunga Research Policy was adopted at Hui 71 (14 February 2022).
- 2. Alongside the policy, the Tūpuna Maunga Authority agreed to make up to \$10,000 available annually to contribute to research projects deemed to be beneficial for the Tūpuna Maunga.
- 3. This funding can be allocated to one or more applicants.
- 4. Aims of the scholarship include:
 - a. provide opportunities for public to engage with the maunga as a space of learning and discovery,
 - b. support student learning, and
 - c. help gather detailed, site-specific information which supports effective management of the maunga.
- 5. The allocation of scholarship funding occurs within the criteria of the Research Policy.

- 6. All decisions of the Authority must consider the legislative and policy framework.
- 7. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 8. The Tūpuna Maunga Authority's Integrated Management Plan was unanimously adopted (Mana Whenua and Auckland Council members) by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.
- 9. The Tūpuna Maunga Authority (Mana Whenua and Auckland Council members) unanimously adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies outline the strategic direction with regards to education, biodiversity, design, recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the maunga.

- 10. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.
- 11. Within the monitoring strategy, mechanisms are outlined which enable the education strategy to be implemented. This includes creation of a list of research projects for tertiary students to undertake as part of their qualifications.

- 12. Management communicated the scholarship through the maunga.nz website, the Love Your Maunga social media channels and targeted promotion to stakeholders and interested parties.
- 13. A letter communicating the commencement of the scholarship round was sent to Mana Whenua, members of the Authority, and other interested parties including Universities and secondary and tertiary education organisations on 30 July 2024.
- 14. The scholarship application period was from 1 August 2024 to 25 September 2024.
- 15. Four scholarship applications were completed and received during the grant round.

Next steps

16. If the Authority allocates the research scholarship funds, Management will inform all applicants of the outcome and work alongside the successful applicants to ensure the research is undertaken successfully, and in accordance with permitting conditions.

Guy Fawkes Response Plan

Recommendation	 That the Tūpuna Maunga o Tāmaki Makaurau Authority: a) note the protection measures, continued since 2020, for the Tūpuna Maunga during the 2024 Guy Fawkes period as set out in the report. 			

Background

- 1. Fireworks are the number one cause of fires on the Tūpuna Maunga.
- 2. At Hui 22 (21 November 2016) following further fireworks fires on the Maunga, the Authority formally opposed the use of fireworks on the Tūpuna Maunga.
- 3. On 5 November 2019, two large fires were started on Maungawhau and Maungarei as a direct result of fireworks. This resulted in the Tūpuna Maunga Authority publicly declaring that the Maunga will be closed during the fireworks period until such a time as the Government bans the sale of fireworks to the public.
- 4. In November 2019, several members of Auckland Council made a submission to parliament seeking a ban on the sales of fireworks to the public. Councillor Cathy Casey, in her capacity as a Ward Councillor for the Albert/Eden ward, was amongst council members who made the submission. Their submission was supported by the Tūpuna Maunga Authority.
- 5. In August 2020, the Parliamentary Governance and Administration Select Committee decided not to ban the sale of fireworks to the public. The Chairperson of the Tūpuna Maunga Authority then wrote to the Prime Minister expressing disappointment in the decision of the select committee.
- 6. If there was any doubt about the need for proactive protection of the Maunga, yet another fire occurred on 7 October 2020 at Maungarei caused by fireworks.
- 7. In 2024, fireworks go on sale from Saturday 2nd November, through to Guy Fawkes Day Wednesday 5th. In previous years the immediate days leading up to, and weekend following Guy Fawkes, have also been times of increased fire risk.
- 8. The Tūpuna Maunga Authority has closed all maunga during this Guy Fawkes period since 2020.

- 9. Any decision to determine management within a reserve must take into account the legislative and policy framework.
- 10. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 11. The Tūpuna Maunga Authority's Integrated Management Plan was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and

Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.

- 12. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 13. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

Overall Approach

- 14. Management have successfully planned and delivered Maunga closures during Guy Fawkes since 2020. These closures are tailored to each Maunga based on risk profile.
- 15. The standard Maunga vehicle access hours are 7am 8.30pm during daylight savings. From Thursday 2nd November through to Sunday 5th November vehicle access gates will be closed at 7.00pm.
- 16. Security teams will be deployed to each Maunga with guards located at all main and secondary entrances from 7.00pm and foot patrols will also be undertaken. All pedestrian visitors will be asked to leave the Maunga at 7.00pm. Vehicle gates will reopen at the standard time of 7am.
- 17. We are now in our fifth year of the Guy Fawkes response and the public are becoming used to the Maunga being closed during this period. This helps with overall awareness and makes it simpler for our security teams.

Public Communications

- 18. The key messages for the media and public are set out in our communications through signage, news articles and interviews.
- 19. Signage advising of the Guy Fawkes Maunga closures, along with the usual 'No Fireworks' signage will be displayed at all Maunga entrances at least three weeks prior to Guy Fawkes to give visitors advance warning.
- 20. A letter mail drop will be completed to residents bordering the Maunga, again advising of the closures. Also included is an update on fire breaks which have been mown around the Maunga perimeters in the lead up to Guy Fawkes week.
- 21. A media release was issued in late October to highlight the Maunga closures and reasoning. This was picked up thorough various media channels.
- 22. The media release will be published as a story on the Our Auckland website and will be shared through Community and Local Board social media channels as well as the Authority's and Auckland Council website pages.

Restoration Planting Programme

- 1. Key principles in the Tūpuna Maunga Integrated Management Plan are:
 - A. To highlight the importance of restoring the Tūpuna Maunga with indigenous ecosystems,
 - B. To reintroduce and attract indigenous and culturally appropriate species, and
 - C. To nurture and enhance the living connections between the Tūpuna Maunga and other areas of indigenous biodiversity in Tāmaki Makaurau.
- 2. To reflect these principles, the ongoing restoration programme of planting native plants on the Tūpuna Maunga continues.

- 3. Any decision to determine management within a reserve must take into account the legislative and policy framework.
- 4. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 5. The Tūpuna Maunga Authority's Integrated Management Plan was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.
- 6. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. - The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

- 8. At Hui 91 (29th April, 2024), management updated the Tūpuna Maunga Authority on the restoration planting programme for the 2024 planting season.
- 9. At the end of this planting season, a total of 37,543 new plantings were planted across the Maunga network between May-September 2024. These plantings are additional to the 186,594 plants already planted over the last 4 years (a total of 224,137 plants).

10. The table below details the total plants planted this year

- 11. The Maunga were planted with appropriate plant species within the guidance of ecosystem type, site suitability, fire retardant and archaeologically appropriate species.
- 12. Management held four community planting days across the Maunga network; Ōtāhuhu / Mount Richmond, Ōhinerau / Mount Hosbon, Ōhuiarangi / Pigeon Mountain and Te Tātua a Riukiuta / Big King, two School plantings on Ōtāhuhu / Mount Roskill and Ōhinerau / Mount Hobson and three organisation plantings on Ōhuiarangi / Pigeon Mountain and Te Tātua a Riukiuta / Big King.
- 13. Community and schools planting dates were best aligned with the Maramataka. Some of the original planting days had to be changed due to wet weather but were still aligned with the Maramataka.
- 14. Tūpuna Maunga Management staff hosted all planting days, welcoming volunteers and providing a tutorial for first-time planters. Each planting day concluded with a barbecue or small kai. In total, management had 315 community registrations from individuals eager to participate in planting on the Tūpuna Maunga. School planting days involved over 150 students from Panama Road Primary School, Pacific Advancement Secondary School, and St Cuthbert's College. Additionally, more than 90 staff members from various teams within Auckland Council took part in organisational planting days.
- 15. For health and safety reasons, there are areas on Maunga where planting could only be undertaken using specialist contractors with the right qualifications and equipment to undertake the work.

16. The multi-year planting programme will continue in 2025 and onwards.

Next steps

17. Management will continue with the ongoing restoration programme including planting maintenance, monitoring and reporting requirements.

Creation of a Bylaw for the Tūpuna Maunga

	 a) request management to draft a bylaw for the Tupuna Maunga network for future consideration by the Authority. 				

Background

- 1. At Hui 93, management identified a future regulatory issue at Matukutūruru once the predator proof fencing has been established. The aim of creating a biodiversity sanctuary would mean that dogs and other animals would need to be excluded from the Maunga to ensure success of the overall project. Two options were presented:
 - a. The Authority creates a dog access policy on Matukutūruru that excludes dogs from the Maunga
 - b. A Reserves Act 1977 bylaw is created with the aim of excluding dogs and other animals from the Maunga under Section 106(1(a))
- 2. At Hui 94, management presented the Authority an analysis of two bylaw options aimed at addressing the regulatory issue:
 - a. A bylaw that would cover all the Tūpuna Maunga (with the exclusion of dogs or other animals from Matukutūruru being laid out in a schedule)
 - b. An individual bylaw for Matukutūruru that would address this regulatory issue.

- 3. This paper relates to Matukutūruru and the wider Tūpuna Maunga network.
- 4. Any decision to determine management within a reserve must take into account the legislative and policy framework.
- 5. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 6. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. One of the values set out in the IMP is Mauri Pūnaha Hauropi (Ecology and Biodiversity). One of the significant pathways to achieve this, states: Protect and restore the biodiversity of the Tūpuna Maunga.

- 7. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 8. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

Reserves Act 1977 Maunga bylaw

Proposed objectives

- 9. The creation of a Tūpuna Maunga bylaw under the Reserves Act will ensure that there is appropriate provision for the exclusion of animals from Matukutūruru which supports the goal of this Maunga becoming a biodiversity sanctuary for our native flora and fauna. With the use of a bylaw, The Authority can also establish the following ancillary objectives:
 - a. Consolidating network-wide policies into one piece of legislation
 - b. Streamlining the legislative process in the future through having the ability to review, update or amend related provisions in one go, rather than individually.
 - c. The centralisation of dog access rules on every Maunga into one piece of legislation to avoid any confusion within the local communities
 - d. Through the bylaw draft process, enabling the Authority to potentially address any historic regulatory gaps on the Maunga.

Recommending the Drafting of a Reserves Act 1977 Maunga Bylaw

- 10. Management recommends that the Tūpuna Maunga Authority initiates work on drafting a Maunga bylaw under the Reserves Act 1977. This bylaw would not only support success of a biodiversity sanctuary on Matukutūruru but would establish a singular, network wide piece of regulatory legislation for the Tūpuna Maunga that will act as the framework for future regulatory policy.
- 11. Management note that the Reserves Act 1977 sets out the public consultation process if the Authority approves any future draft Maunga Bylaw.
