Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014

109 Functions and powers

- (1) The Maunga Authority has the powers and functions conferred on it by or under this Act or any other enactment.
- (2) In exercising its powers and carrying out its functions in relation to the maunga, the Maunga Authority must have regard to—
- (a) the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau; and
- (b) section 41(2).
- (3) In exercising its powers and carrying out its functions in relation to the administered lands, the Maunga Authority must have regard to the spiritual, ancestral, cultural, customary, and historical significance of the administered lands to Ngā Mana Whenua o Tāmaki Makaurau.

[Emphasis added]

41 Maunga must remain as reserves vested in trustee

- (1) This section applies to each maunga once the maunga is—
- (a) vested in the trustee under subpart 1, 2, or 3 of this Part;

and

- (b) Declared a reserve under any of sections 18 to 29, 33, and 39.
- The maunga is held by the trustee for the common benefit of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

Tūpuna Maunga Authority Term Highlights

Purpose	To review and celebrate the achievements of the Tūpuna Maunga Authority over the 2022-2025 term.
Recommendations	That the Tūpuna Maunga Authority: a) note the highlights over the 2022-2025 term of the Tūpuna Maunga Authority.

1. With Hui 102 being the final hui before the end of the term, Management have reviewed the Tūpuna Maunga Authority's projects and activities over the last three years.

Acknowledgement

2. Commemorating the passing of Clay Hawke, the Tūpuna Maunga Authority recognises his significant mahi to promote the health and wellbeing of Tūpuna Maunga o Tāmaki Makaurau. Clay was appointed to the Authority on 20 March 2020 and made a valuable contribution as a committed and active member of the Authority until his retirement earlier this year.

Tūpuna Maunga Authority Awards

- 3. Maungawhau Green Flag Award, an international accreditation recognised as being the benchmark standard for the management of outdoor spaces.
- 4. Maungawhau Boardwalk Tūpuna Mauna Authority jointly awarded the Resource Management Law Association (RMLA) in partnership with Isthmus Group Ltd.
- 5. Te Pane o Mataoho / Te Ara Pueru / Māngere Mountain Designers Institute of New Zealand Best Design Awards. Bronze Award presented to Boffa Miskell design team for their collaboration with the Tūpuna Maunga Authority on the Hāngī Pits and Kai Space at Whānau Ātea.

Vegetation Restoration

- 6. During the 2025 planting season 28,808 new plants were spread across; Te Pane o Mataoho / Te Ara Pueru / Māngere Mountain, Ōtāhuhu / Mount Richmond, Puketāpapa / Pukewīwī / Mount Roskill, Matukutūruru / Wiri Quarry, Te Tātua a Riukiuta / Big King, Ōhuiarangi / Pigeon Mountain, Maungawhau / Mount Eden, Ōwairaka/Mt Albert, Ōhinerau / Mt Hobson and Takarunga / Mt Victoria.
- 7. This is an addition to the approximately 224,137 plants already planted over the last 5 years bringing the total to 252,945 plants across the Maunga network.
- 8. Ongoing management continues across Maunga to ensure high survival rates of these plants are prioritised, including maintenance, monitoring and reporting requirements.

Mahi mo te Taiao/ Jobs For Nature

- 9. The three-year conservation programme Jobs for Nature between the Tūpuna Maunga Authority and the Department of Conservation ended in April 2025. The injection of funding over the last three years has helped the Authority achieve key restoration goals and provided many training opportunities and experience for kaimahi involved with the programme.
- Approximately 29 full-time employees were employed over the course of the contract, meeting the programme's objective to create job opportunities as part of the COVID-19 recovery.
- 11. Environmental outcomes achieved through this project over the last three years are;
 - Over 230ha of possum, rat and mustelid control.
 - Over 147ha of other pest animal control
 - Over 180ha of pest plant control
 - 1.42ha of wetland restored
 - Approximately 101,000 native plants planted
 - Approximately 7ha of non-wetland areas restored
 - Fauna and flora monitoring across all the Maunga
- 12. Two of the suppliers from the Jobs for Nature programme have signed on to continue working on the Maunga through pest plant and animal control as well as vegetation restoration. The goal is to maintain the biosecurity and biodiversity baseline that Jobs for Nature has created with a reduced budget.

Pest Control

- 13. The regular programme of pest animal and plant control has resumed on all Maunga with under a reduced budget with the ending of the Jobs for Nature programme in April 2025. These contracts undertake pest animal and plant management, restoration vegetation programme and implements both biodiversity and biosecurity monitoring to ensure positive conservation outcomes are gained.
- 14. Management have undertaken ongoing pest control on all Maunga for both pest plants and pest animals.
- 15. Rabbit control on the Maunga continues with the aim of eradication across all sites. A rabbit contractor with a specialised rabbit dog is utilised to survey the Tūpuna Maunga. Rabbits have been picked up on some of the Maunga and subsequently controlled. Control and monitoring will continue on a regular basis.
- 16. A number of significant projects and activities have been carried out across the Tūpuna Maunga to support ecological restoration and strengthen community engagement over the past three years. These activities include a regular programme of pest animal and plant control, wildlife monitoring (including lizards, birds, and bats), and ongoing maintenance of trees and firebreaks.

Tūpuna Maunga Authority Research Scholarship

17. To date, \$20,000 dollars have been allocated to 3 recipients, working in visual arts, volcanology, and anthropology.

Events, Activations and Education Opportunities

Public Events on the Maunga

18. 131 public events have been approved by the Authority to be held across the Tūpuna Maunga network.

Matariki activities

19. A number of events across the Tūpuna Maunga were supported by management, including a presence at the Puketāpapa Manu Aute Kite Day, with activities, such as īngoa boards, for whānau to engage in.

Love Your Maunga

- In 2023, a Love Your Maunga event was held on Maungawhau / Mount Eden. In 2024 and 2025, two Love Your Maunga Events have been held on Te Pane o Mataoho / Te Ara Pueru / Māngere Mountain.
- 21. Love Your Maunga featured kemu Māori, conservation engagement, and a hāngī fundraiser for local community groups.
- 22. Attendance was estimated at over 900, and approximately \$10,500 was raised for Onehunga-Māngere United Association Football Club, Māngere Enviro Hub, and Māngere Mountain Education Centre.

Halo Event

- 23. In February 2025, a Halo pop-up event was held on Maungauika / North Head to engage with the local community and raise awareness about the importance of pest control and biodiversity restoration on the two Northern Tūpuna Maunga. There were over 100 attendees.
- 24. The event was partnership between the Tūpuna Maunga Authority and Restoring Takarunga Hauraki, and included information tents, interactive activities, kai, and free T-Rex traps for the community.

Progress on Maunga

25. Specific activities and projects undertaken on individual Tūpuna Maunga include the following:

Matukutūruru / Wiri Mountain


26. Redevelopment of the carpark at Matukutūruru to create a safer entrance and raise the profile of Matukutūruru as a Tūpuna Maunga.

27. The construction of a formal walking track at Matukutūruru, along with two viewing platforms highlighting views to other Maunga. The planting works as part of this project contribute to, and are supported by, the other significant planting being undertaken at this Maunga.



Maungakiekie / One Tree Hill

- 28. Installation of the auto gate at Manukau Road.
- 29. Transformation of the Olive Grove Road at Maungakiekie to a pedestrian space.



30. Constructed stairs over eroded track.



Maungarei/ Mt Wellington

31. The upgrade of secondary tracks has been completed. These enhancements are designed to improve accessibility while preserving the cultural and archaeological integrity of the maunga, thereby enhancing the overall experience for all manuhiri (visitors).



Maungauika/ North head

32. A guided hīkoi was held on Maungauika during the school holidays to encourage whānau to engage with the maunga and learn about the rich cultural heritage of the the Tūpuna Maunga (ancestral mountains) of Tāmaki Makaurau.



Maungawhau/ Mt Eden

33. The extension of the innovative and award-winning boardwalk on Maungawhau / Mt Eden has now been completed, providing visitors with an enhanced and more comprehensive walking experience around the tihi.



<u>Ōhinerau/ Mt Hobson</u>

- 34. Stair construction over an eroded track has been completed, improving access and safety on the maunga..
- 35. Secondary track upgrades on the maunga have been completed, improving accessibility, safety, and the overall visitor experience.



Pukewīwī / Puketāpapa / Mt Roskill

36. Installation of autogate to reduce unwanted and inappropriate behaviours overnight.

Te Ara Pūeru / Te Pane a Mataaho / Māngere Mountain

The network of secondary tracks around Te Ara Pūeru / Te Pane a Mataaho / Māngere Mountain has been upgraded, enhancing access and visitor safety on the Maunga.



38. The whānau ātea at Te Pane a Mataoho, Te Ara Pueru, Māngere mountain was completed and opened to the public at the end of December 2022.





Takarunga/ Mt Victoria

39. The revitalisation of the tihi has been completed, significantly improving accessibility for all visitors. The project included, reduction or impermeable surfaces, the creation of new pathways, installation of seating, and removal of the trig station – see the photos showing before and after the project was completed.





Ōtāhuhu/ Mt Richmond

40. The secondary track has been upgraded at Ōtāhuhu / Mt Richmond to improve access and protect the site's cultural and ecological features.



Te Tātua-a-Riukiuta/ Big King

41. The existing walkways at Te Tātua-a-Riukiuta / Big King have been upgraded and resurfaced to enhance accessibility and protect the cultural and environmental values of the Maunga.



RMA Ropū

- 42. With increasing resource consent and resource management issues, the Authority established the RMA Rōpū as a sub-committee at Hui 30 on 16 October 2017. The Rōpū has sought to protect the Maunga from damage and negative impacts arising from some development and has focused on protecting the viewshafts to, from, and between the Maunga and restricting building heights and excavation around the Maunga.
- 43. The RMA Ropū has been active in following areas:

Consultation and engagement

- 44. There is increasing consultation and engagement with the Authority, and this has been assisted by:
 - Management presentations to the resource consents team and planning team.
 - Active and prompt responses to the Maunga Authority email in-box.
 - Encouraging pre-application engagement.
 - Using experienced planning consultants familiar with RMA Ropū policy.
- 45. Early consultation and engagement enables influence over the design to better align with IMP values and RMA Rōpū policy. This has included:
 - Changes to design to comply with maunga viewshafts.
 - Changes to designs to reduce the extent of excavation.
 - Native planting suitable for WF7 forest areas.
 - Fencing on the boundary with the Maunga that excludes direct access from private property.
 - A reduction in the number of applications seeking infringements to Maunga Viewshafts.

Resource consent applications

- 46. Feedback includes review of the weekly list, responding to requests for input from the resource consent team and making submissions on applications. Key successes include:
 - Resource consent application by Dilworth Trust for buildings exceeding height sensitive areas height limit refused on the basis of evidence presented by the Authority. This application was at 92, 96 and 98 Great South Road, Remuera for the construction of 100 residential units/apartments. The Authority submitted evidence at a hearing in November 2022, opposing the application on the grounds that it would negatively impact the visual integrity of Ōhinerau / Mount Hobson by dominating the view from Great South Road and diminishing the ability of viewers to appreciate the Maunga. The decision of hearing commissioners accepted and supported The Authority's submission, and the development did not proceed.
 - Decisions on applications for temporary cranes intruding into viewshafts including conditions developed by the Authority to limit the visual impact of the cranes of the Maunga.

Plan changes

- 47. Submissions have been made to two plan changes in the last term. Both have resulted in the hearings panel accepting key parts of the Authority's submissions:
 - Plan Change 78: Intensification (PC78) to the Auckland Unitary Plan (Operative in Part) The Authority submitted on PC78 to ensure Maunga viewshafts and height-sensitive areas around the Maunga are protected. The Authority also sought to protect the views between the Maunga (Maunga to Maunga views). In May 2025, for the City

Centre, an Independent Hearings Panel recommended retaining the existing Maunga viewshafts as a qualifying matter and adopting the evidence of the planning and landscape specialists regarding temporary activities within these viewshafts. The Panel also recommended that the "Maunga to Maunga" viewshafts be included as a new qualifying matter.

Plan change 106: Filming on Sites and Places of Significance to Mana Whenua. The Authority submitting on PC106 seeking the plan change also apply to land administered by the Authority. This was accepted without change by the hearings panel. The Authority also sought to expand the plan change to provide for other temporary activities on the Maunga. The panel determined this to be out of scope. This is not unexpected.

Fire and Emergency New Zealand (FENZ)

48. Management have collaborated closely with FENZ to advance fire management planning for the maunga. The planning process is focused on protecting both the maunga and adjacent properties through proactive risk mitigation and site-specific strategies.

General and Policy

Integrated Management Plan Amendment 2022

- 49. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977 at Hui 19 (23 June 2016). The Tūpuna Maunga Authority has consistently prioritised the restoration of biodiversity through strategic pest control and the planting of native species. These initiatives are essential to the ongoing journey of ecological restoration and play a crucial role in honouring the inherent spiritual and ancestral significance of the Tūpuna Maunga (ancestral mountains) of Tāmaki Makaurau.
- 50. The 2022 amendment to the Tūpuna Maunga Integrated Management Plan was developed to support ecological restoration projects across four Maunga (Ōwairaka / Mount Albert, Pukewīwī / Mount Roskill, Ōtāhuhu / Mount Richmond, and Te Tātua-a-Riukiuta / Big King). These projects included the planting of indigenous species and the removal of exotic trees. The amendment process incorporated a public consultation phase, undertaken in accordance with a Court of Appeal ruling that introduced revised legal procedures for the management of the Maunga. The amended IMP was formally adopted in November 2022, reflecting the feedback received through the public consultation.

Maunga Protection - Guy Fawkes and Fire safety

51. The successful implementation of annual fire safety measures during the Guy Fawkes season included evening access restrictions from 2–6 November and a coordinated security presence across the Maunga network. Initiated in 2020, the Guy Fawkes campaign is now well-established, with Maunga closures enhancing public awareness and streamlining security operations. As a result, 2025 marked the fifth consecutive year without non-intentional fire incidents on the Maunga during this period.

Individual Maunga Plans

52. At Hui 85 (10 July 2023) the Tūpuna Maunga Authority adopted its first tranche of three Individual Tūpuna Maunga Plans for: Maungarei/ Mount Wellington, Ōhuiarangi/ Pigeon Mountain and Matukutūruru / Wiri Mountain. Individual Maunga Plans complete the Integrated Management Plan framework, guiding restoration work; they give effect to the Authority's values and strategies, detailing actions to enhance the health and well-being of the Tūpuna Maunga. Individual Tūpuna Maunga Plans are recognised as living documents and may be reviewed or amended by the Authority at any time.

Dog Policy Update

53. At Hui 95, the Authority directed management to make a submission to the Auckland Council on its review of the Auckland Council Policy on Dogs 2019, seeking the removal of all Tūpuna Maunga from Schedule 2 of that policy. The new Auckland Council Policy on Dogs 2025 has deferred the remaining Maunga into Schedule 1, meaning that decision making authority for all Maunga now resides with the Authority.

Leases

- 54. Tūpuna Maunga Authority leases have been executed which recognise the privilege for lessees to occupy space on Maunga. These leases have rentals at market value to acknowledge the privilege granted to lessees to occupy space on the Maunga.
- 55. During the term, the Authority has approved seven leases.

Recommendations	 That the Tūpuna Maunga Authority: a) approve the Draft Tūpuna Maunga Authority Operational Plan 2026-27 and the Draft Summary of the Tūpuna Maunga Authority Operational Plan 2026-27; and b) note the Auckland Council Governing Body will be invited to approve the Draft Tūpuna Maunga Authority Operational Plan 2026-27 and the Draft Summary of the Tūpuna Maunga Authority Operational Plan 2026-27 for inclusion in the Auckland Council's Annual Budget 2026-27.

Background

- 1. The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Tūpuna Maunga Authority and Auckland Council to agree an annual operational plan and a summary of that plan for inclusion in council's annual plan.
- 2. At Hui 99 (26 May 2025), the Authority adopted the Tūpuna Maunga Authority's Operational Plan 2025-26 and the Summary. These budgets have been agreed by the Auckland Council on 28 May 2025.
- 3. The Draft Operational Plan 2026-27 presented as part of this report (Attachment A) is within the Long-term Plan 2024-2034 funding envelope agreed by the Authority and Auckland Council.

Statutory Context

- 4. The process and any decision to adopt an Operational Plan, and summary thereof, is required to take into account the legislative and policy framework.
- 5. Section 109(2) of Ngā Mana Whfenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 6. The Tūpuna Maunga Authority's Integrated Management Plan was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.

- 7. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
- 8. The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 sets out a process for the adoption of an "Annual Operational Plan" by the Authority (refer sections 60-63). Management have worked alongside the council's legal and finance teams to ensure compliance with the procedures set out in the legislation.
- 9. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

Draft Operational Plan 2026-27

- 10. Management are proposing minor changes to the operational plan for the coming financial year. The budgets while within the LTP envelope have realigned some figures through the next three years to match the Authority's work programme more accurately.
- 11. Management consider we will see a peak of operational spend around 2030-31 and a steady reduction of capital costs as we shift away from a strong period of infrastructure growth towards a programme of renewals with the occasional signature project.
- 12. Section 62 of the Act provides for Auckland Council to meet the costs in relation to the maunga and the administered lands to the extent that funding and revenue for the maunga and the administered lands allow.


Next Steps

- 13. Once approved by the Maunga Authority, the Auckland Council's Governing Body will be invited to approve the Authority's operational plan, including a summary of the Operational Plan for inclusion in the council's draft Annual Budget 2026-27.
- 14. The indicative timeframes for the development and adoption of council's Annual Plan 2026-27 are:
 - Council decision making on the draft Operational and Mayoral proposal/consultation documents: early – mid February 2026
 - Public Consultation by the Authority and Auckland Council: late February to late March 2026
 - Joint workshop of Authority and Auckland Council: anticipated end of April 2026
 - Deliberations: April to May 2026
 - Adoption of Operational Plan as final: by end of June 2026.
- 15. The Maunga Authority will, as in previous years, carry out its own consultation process on the annual operational plan alongside the council's process.

Ngā Tūpuna Maunga o Tāmaki Makaurau

The ancestral mountains of Auckland

It is the rich history of Māori connection to the Maunga (volcanoes) of Tāmaki Makaurau / Auckland, unbroken over time, that sets them apart from any other volcanic landscape in the world.

As Māori established here, the Maunga were valued as natural places for pā (settlements), with their rich volcanic soils and their unique form and height for easy defence. The number of Maunga pā across Tāmaki Makaurau made it an important region of Māori social organisation and a main location for trade between tribes throughout Aotearoa / New Zealand.

The Maunga are central to the spiritual and cultural identity of Māori.

A defining principle in te ao Māori (the Māori world) is kinship. All the myriad elements of creation – the living and the dead, the animate and inanimate – are inter-related. All are infused with mauri (life force) and wairua (spirit), and all are related through whakapapa (common descent) from Ranginui (Sky Father) and Papatūānuku (Earth Mother).

In Māori culture, the people of a place are related to its mountains, rivers and species of plant and animal, and regard them in personal terms. Wairuatanga (spiritual

connections) between people and the natural world is an integral part of traditional Māori cultural practices.

Tikanga (protocols) have been established over time to ensure that resources are harvested sustainably and that the relationship with the natural environment remains balanced. The Maunga, as with all of the natural environment, are governed by fundamental values such as kaitiakitanga (guardianship), manaakitanga (care and generosity) and utu (reciprocity) which reinforce a sense of belonging and social cohesion.


To Nga Mana whenua o Tāmaki Makaurau (the Māori tribes of Auckland), the Maunga are living entities with mauri and wairua. They are regarded as Tūpuna (ancestors), and as taonga tuku Iho (treasures to be handed down the generations).

In recognition of the deep spiritual, cultural and customary connection between the Maunga and the Māori people of this land, the Auckland volcanic field heads New Zealand's working list for World Heritage status with the United Nations Educational, Scientific and Cultural Organisation (UNESCO).

The Tūpuna Maunga Redress

The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Settlement is an outcome of Mana Whenua and the Crown settling historical Treaty of Waitangi breaches. The settlement recognises that the Tūpuna Maunga are taonga in relation to which Mana Whenua have always maintained a unique relationship and honours their intergenerational role as kaitiaki (guardians).

In July 2014, the Collective Redress Act was passed. The Act vested the Crown-owned land of 14 Tūpuna Maunga in Ngā Mana Whenua o Tāmaki Makaurau, on the basis that they are held in trust for the common benefit of the iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

The Tūpuna Maunga are owned by the 13 iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau via the Tūpuna Taonga o Tāmaki Makaurau Trust.

Under the Act each Tūpuna Maunga was declared a reserve and the Tūpuna Maunga Authority was appointed as the administering body for the majority of the Maunga for the purposes of the Reserves Act 1977.

THE EXCEPTION IS:

 Rarotonga /Mount Smart which is vested in the Taonga Trust and administered by Auckland Council (Regional Facilities Auckland) under the Mount Smart Regional Recreation Centre Act 1985 and Reserves Act 1977.


The Collective Redress Act also transferred the administration of the following reserve land retained in Crown ownership to the Tūpuna Maunga Authority:

- Te Pane-o-Mataaho /Te Ara Pueru/ Māngere Mountain – ownership of the land remains with the Crown and is administered by the Tūpuna Maunga Authority under the Collective Redress Act and Reserves Act.
- Maungakiekie / One Tree Hill Northern land ownership of the land remains with the Crown and it is administered by the Tüpuna Maunga Authority under the Collective Redress Act and Reserves Act.

NGĀ MANA WHENUA O TĀMAKI MAKAURAU

Ngā Mana Whenua o Tāmaki Makaurau is the collective name of the 13 iwi/hapū with historical Treaty claims in the wider Tāmaki Makaurau. The iwi/hapū are grouped into the following three rōpū:

- Marutūāhu Rōpū: Ngāti Maru, Ngāti Pāoa, Ngāti Tamaterā, Ngāti Whanaunga, Te Patukirikiri;
- Ngāti Whātua Rōpū: Ngāti Whātua o Kaipara, Ngāti Whātua Ōrākei, Te Rūnanga o Ngāti Whātua; and
- Waiohua Tāmaki Rōpū: Ngāi Tai ki Tāmaki, Ngāti Tamaoho, Ngāti Te Ata, Te Äkitai Waiohua, Te Kawerau ā Maki.

The collective approach recognises that the iwi and hapū have various shared customary interests within Tāmaki Makaurau such that a collective settlement approach is appropriate. It also provides for the greater exercise of whanaungatanga and kotahitanga between the iwi/hapū.

The sections for each of the Tūpuna Maunga within this document show the individual iwi and hāpu customary association with that Tūpuna Maunga as recorded in the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Deed of Settlement.

TŪPUNA TAONGA O TĀMAKI MAKAURAU TRUST

The Tūpuna Taonga o Tāmaki Makaurau Trust (Trust) was set up to receive the Tāmaki Collective cultural redress arising out of the Collective Redress Act.

The Trust receives, administers, manages, protects and governs the assets of the Trust for and on behalf of the 13 iwi and hapū of Ngā Mana Whenua o Tāmaki Makaurau.

The Trust's Statement of Intent 2017/18 confirms the Trust's strategic objectives as:

- Toitū te whenua, whatu ngarongaro te tangata
 Enduring protection and management of cultural redress properties
- Tē tōia, tē haumatia
 A sustainable Trust that fulfils its purpose well
- Toitū te kupu, toitū te mana, toitū te whenua
 A strong Mana Whenua presence and connection to cultural redress
- Mā whero, mā pango ka oti ai te mahi Enduring relationships and collaboration.

TŪPUNA MAUNGA AUTHORITY

The Tūpuna Maunga Authority is the statutory authority established under the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act to co-govern the Tūpuna Maunga. The inaugural hui was held in November 2014.

The Tūpuna Maunga Authority has six representatives appointed by Ngā Mana Whenua o Tāmaki Makaurau and six appointed by council. The Minister for Arts, Culture and Heritage may also appoint a non-voting Crown representative.

The Tūpuna Maunga Authority is independent of council and has its own decision-making powers and functions. Council is responsible for the routine management of the Maunga under the direction of the Tūpuna Maunga Authority.

The Tūpuna Maunga Authority's bespoke co-governance structure recognises not only the important relationship Ngā Mana Whenua have with these sacred places, but also their importance to, and connection with, all the peoples of Auckland. The Tūpuna Maunga Authority is a tangible expression of the spirit of partnership between Ngā Mana Whenua and council.



AUCKLAND COUNCIL

Auckland Council is responsible for the routine management of the Tūpuna Maunga under the direction of the Tūpuna Maunga Authority. It is responsible for the costs in relation to the Tūpuna Maunga and administered lands incurred by council and the Tūpuna Maunga Authority in carrying out their respective functions under the Collective Redress Act or the Reserves Act 1977.


Council must also provide the Tūpuna Maunga Authority with the administrative support necessary to carry out its functions and to exercise its powers. This responsibility is within the extent that funding and revenue for the Maunga and the administered lands allow.

TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN

The Tūpuna Maunga Integrated Management Plan ("IMP") sets the foundations for how the Tūpuna Maunga are valued, protected, restored, enhanced, and managed in the future with equal consideration and reverence. The IMP established a set of Values for the Tūpuna Maunga which are outlined below.

The IMP was developed in accordance with Section 41 of the Reserves Act to provide for and ensure the use, enjoyment, maintenance, protection, preservation, and development as appropriate for the reserve purposes for which each of the Tūpuna Maunga is classified. This single integrated plan replaces the former separate legacy reserve management plans for the Tūpuna Maunga.

The IMP was approved in 2016 following a public consultation process and can be read online at www.maunga.nz.1

TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN STRATEGIES

The Tūpuna Maunga Integrated Management Plan Strategies are the next level of policy development for the Tūpuna Maunga and aim to support the Values and Pathways in the Tūpuna Maunga Integrated Management Plan 2016.

The IMP Strategies was approved in 2019 following a public consultation process and can be read online at www.maunga.nz.

TŪPUNA MAUNGA INDIVIDUAL MAUNGA PLANS

The Individual Maunga plans (Maunga Plans) are the final tier of policy development and complete the series of documents as part of the Integrated Management Plan Framework. The Plans give effect to the Values, Pathways, Guidelines and Strategies and provide further detail with regards to the work the Authority is undertaking to enhance the health and well-being of the Tūpuna Maunga. The Maunga Plans are living documents that can be updated in accordance with future Annual Operational Plans.

The first 3 Maunga Plans were approved in July 2023. Further Individual Maunga Plans will be developed over the course of the current term of the Tūpuna Maunga Authority.

TŪPUNA MAUNGA VALUES

Within the Tūpuna Maunga Integrated Management Plan, the Tūpuna Maunga Authority has articulated a set of values of the Tūpuna Maunga. The values promote the statutory purpose of the Tūpuna Maunga under section 109 of the Collective Redress Act, where in exercising its powers and functions the Authority must have regard to the spiritual, ancestral, cultural, customary and historical significance of the Tūpuna Maunga to Ngā Mana Whenua.

The values provide a strategic framework to guide the Tūpuna Maunga Authority in making any decision about the Tūpuna Maunga.

The values weave together and give expression to mana whenua and other world views, and the connections and histories in a manner that highlights the way in which these views complement each other and create a richness to the relationship people have with the Tūpuna Maunga and multiple ways in which these relationships are thought of and expressed.

The Tūpuna Maunga Authority Operational Plan

For each financial year the Tūpuna Maunga Authority and Auckland Council (council) must agree an operational plan. The plan outlines how council will carry out the routine maintenance of the Tūpuna Maunga (ancestral mountains) and administered lands under the direction of the Tūpuna Maunga Authority. This is a requirement under section 60 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 (the Collective Redress Act).

The operational plan outlines the work programme for the financial year, which comprises of a number of projects at a network and individual Maunga level. Importantly, the operational plan sets out how these individual projects contribute to delivery of the Tūpuna Maunga Authority's

objectives and vision for the Tūpuna Maunga by linking them to one or more of the Tūpuna Maunga Values in the Integrated Management Plan.

This Operational Plan covers the financial years 2026/27, 2027/28 and 2028/29 in detail. Network-wide budgets are shown for a number of programmes. Once the guidelines and strategies and individual Maunga plans have been developed, these will be able to be further refined to show spend on individual Maunga.

This Operational Plan also includes the funding envelope for the third year of the Auckland Council 10-year Budget (Longterm Plan) 2024-34.

WORK PROGRAMME OVERVIEW

In addition to expressing the objectives and vision for the Tūpuna Maunga, the values are the key driver of the Tūpuna Maunga work programme (see Table 1).

This work programme is a continuation from the Long-Term Plan 2024-34. This year's operational plan reflects the progress that has been made on this programme and includes further projects which have emerged from the Tūpuna Maunga Strategies.

The outer years of the proposed work programme foreshadow a change in the focus of the Authority as the significant CAPEX projects are completed.

Priority programmes and projects over the next 3 years include:

POLICY AND MANAGEMENT

- Develop individual Tūpuna Maunga plans to provide direction on how the Values, Pathways, guidelines and strategies should be reflected on each Tūpuna Maunga.
- Progressing the potential transfer of administration over certain Maunga reserve lands from the Department of Conservation to the Authority, and the potential transfer of the administration of land contiguous to other Tūpuna Maunga.
- Establishment of a compliance programme including a review of current and establishment of appropriate bylaws.

HEALING THE MAUNGA

VALUES:

TAKOTORANGA WHENUA / LANDSCAPE VALUE

- Protection and restoration of the tihi (summits) including reconfiguring space and provision of cultural infrastructure.
- Protection and restoration of historic kumara pits, pā sites and wahi tapu.
- Development of infrastructure to enhance visitor experience including provision of carparks, amenity areas, tracks and ancillary infrastructure such as wharepaku/ toilets.

EDUCATION, COMMUNICATIONS AND PARTNERSHIPS

VALUES:

WAIRUATANGA / SPIRITUAL VALUE

- On-site staff to protect and enhance the Tūpuna Maunga and the visitor experience.
- Volunteer programmes to connect communities to the Tūpuna Maunga.
- Education programmes, community events and a bespoke website that celebrates the living connection that all communities have with the Tūpuna Maunga.
- Implementation of the Education Strategy to promote the values of the Tūpuna Maunga and the unique history and whakapapa of Ngā Mana Whenua. This includes exploration of visitor centre opportunities, connecting with communities of learning such as schools and the development of a communications strategy.

CULTURAL CONNECTION

VALUES:

MANA AOTŪROA / CULTURAL AND HERITAGE VALUE

MANA HONONGA TANGATA / LIVING CONNECTION VALUE

- Development of a programme of work which enables Ngā Mana Whenua to express their living and unbroken connection with the Tūpuna Maunga. This may include cultural interpretation including distinct entrance ways, pou whenua, pa reconstructions, kaitiaki opportunities, and other cultural activities.
- Mana whenua living connection programme focusing on their role as kaitiaki (guardians), restoring customary practices and associated knowledge and enabling cultural activities.

BIODIVERSITY/BIOSECURITY

VALUES:

MAURI PŪNAHA HAUROPI / ECOLOGY AND BIODIVERSITY VALUE

- Restoration of indigenous native ecosystems; reintroducing native plants and attracting native animal species; removing inappropriate exotic trees and weeds (For context, see pages 58, 65-66, 71, 87,88 90-91, and appendix 5 of the amended Tūpuna Maunga Authority Integrated Management Plan, and at pages 7 and 34 of the Integrated Management Plan Strategies).
- Pest control on all Maunga in line with Auckland's plan to be pest free by 2050.
- Researching options to achieve efficient and effective animal and pest control methods, which includes a phased reduction in the use of herbicides and pesticides on the Tūpuna Maunga.
- Establishing a pest-proof fencing solution at Matukutūruru.

RECREATION AND ACTIVATION

VALUES:

MANA HONONGA TANGATA / LIVING CONNECTION VALUE

MANA WHAI A RĒHIA / RECREATIONAL VALUE

 Exploration of facilities and activities on, around and between the Tūpuna Maunga which provide for passive and active recreational opportunities.

COMMERCIAL

VALUES:

WHAI RAWA WHAKAUKA / ECONOMIC / COMMERCIAL VALUE

 Develop and implement a commercial framework which ensures continued investment back into the Tūpuna Maunga. This includes exploration of potential commercial activities and facilities, as well as the development of a concession framework for commercial operators on the Maunga. All projects are designed to deliver outcomes for the 13 iwi/hapū of the Tāmaki Collective and all the people of Auckland, enhance the mana and mauri of the Tūpuna Maunga and deliver improved open spaces across the eight local board areas.

They will also enable a compelling case in a future UNESCO World Heritage bid for the Tūpuna Maunga, which will contribute to a Māori identity that is Auckland's point of difference in the world. The bid for World Heritage status will require a dedicated resource and will continue to be progressed in this financial year in partnership with the Department of Conservation.

The Tūpuna Maunga Authority plans various programmes to support Ngā Mana Whenua o Tāmaki Makaurau. Some key programmes for each Maunga and the administered lands discussed in this Operational Plan are:

- on-site interpretation/storytelling projects that recognise and share with visitors the relationships of mana whenua to the Tūpuna Maunga,
- education programmes developed, in partnership with mana whenua that help share the values of the Tūpuna Maunga and increasing support for the protection and restoration of these values,
- projects that work with mana whenua to identify and implement infrastructure and programmes that will support mana whenua reconnecting with the Tūpuna Maunga,
- · a network-wide programme to work with mana whenua to identify, protect and heal sites of significance,
- · general engagement and consultation to seek technical and landowner input into projects and programmes; and
- · supporting events where possible including mana whenua cultural activities.

These are then phased over the short, medium and long term. It includes policy projects as well as operational and capital projects. Funding and revenue for the Maunga must be:

- Held and accounted for separately by council
- Applied by council under the direction of the Tūpuna Maunga Authority and in accordance with the annual operational plan

Every 3 years council must prepare and adopt a 10-year Budget (Long Term Plan) which describes the activities of the council and forecast expenditure and funding requirements for the next 10 years.

The expenditure and funding requirements for the Maunga Authority for 10 years are included in the council's 10-year Budget (Long-term Plan) 2024-34 are shown in Table 2.

This operational plan sets out the detailed expenditure and revenue for the 2026/27 and indicative financial information for 2027/28 and 2028/29. The annual operational plan for 2026/27 and the subsequent years fits within this funding envelope. The Tūpuna Maunga Authority manage the Maunga as a network. The individual Maunga sections set out maunga-specific costs for programmes and projects where these have been identified and scoped. The networkwide programmes require further project planning to determine how they will be applied to each Maunga.

Any budget variation associated with individual projects or network-wide programmes will be shared across the network in accordance with the priorities set out in Table 2 and kept within the total funding envelope.

OPERATIONAL EXPENDITURE

Net operating expenditure covers income and expenditure from day-to-day operations and services.

The operational expenditure shown in the individual Maunga sections is in future year dollar terms. The annual inflation rates applied are based on the rates used in the Auckland Council Long-term Plan 2024-34.

CAPITAL EXPENDITURE

CAPITAL DEVELOPMENT PROJECTS

These are for the creation or purchase of new assets, typically to address growth in demand, changes to the required Level of Service and to be consistent with the Tūpuna Maunga values and pathways as identified in the Integrated Management Plan. Any new Capital Project to be delivered are identified under each Maunga.

The Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 (the Act) requires the Tūpuna Maunga o Tāmaki Makaurau Authority (Tūpuna Maunga Authority) and Auckland Council to prepare an Annual Operational Plan and a summary of that plan for inclusion in the Auckland Council's Annual Operational Plan 2026/27 process.

The Tūpuna Maunga Authority and Auckland Council are required to approve the Annual Operational Plan. The Tūpuna Maunga Authority Operational Plan 2026/27 must be considered and adopted concurrently with the Auckland Council's Operational Plan 2026/27. A summary of the Tūpuna Maunga Authority's indicative funding requirements are outlined in this Section.

NGĀ MANA WHENUA O TĀMAKI MAKAURAU

Ngā Mana Whenua o Tāmaki Makaurau negotiated a collective settlement of their historical Treaty claims with the Crown. Ngā Mana Whenua o Tāmaki Makaurau is the collective name of the 13 iwi/hapū with historical Treaty claims in wider Tāmaki Makaurau. The iwi/hapū are grouped into the following three rōpū:

THE NGĀ MANA WHENUA O TĀMAKI MAKAURAU COLLECTIVE REDRESS ACT 2014

The Collective Redress Act 2014 vested the Crown owned land in 14 Tūpuna Maunga (ancestral mountains) in Ngā Mana Whenua o Tamaki Makaurau. They are held for the common benefit of the iwi/hapū of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland. The Tūpuna Maunga are vested as reserves under the Reserves Act 1977.

CO-GOVERNANCE

The Act also established the Tūpuna Maunga Authority, a bespoke co-governance entity, to administer the Tūpuna Maunga.

The Authority has six representatives from Ngā Mana Whenua o Tāmaki Makaurau, six from Auckland Council and one non-voting Crown representative appointed by the Minister for Arts, Culture and Heritage. The term of the Authority aligns with the term of the Council.

Under the Act, the Tūpuna Maunga Authority is the administering body for each Maunga for the purposes of the Reserves Act 1977, with two exceptions of Maungauika / North Head and Rarotonga / Mount Smart.

Maungauika / North Head has previously been administered by the Crown (Department of Conservation) but has now been transferred to the Tūpuna Maunga Authority. Routine management is now undertaken by council under the direction of the Tūpuna Maunga Authority in the same way as for the other Maunga.

Responsibility for administration and management of Rarotonga / Mount Smart remains with Auckland Council (Regional Facilities Auckland) under the Mount Smart Regional Recreation Centre Act 1985 and Reserves Act 1977.

The Tūpuna Maunga Authority is also the administering body for Te Pane-o-Mataaho / Te Ara Pueru / Māngere Mountain and the Maungakiekie / One Tree Hill northern land

The legislation provides for funding and staff resourcing through Auckland Council. The Authority is currently supported by a core team of eight council staff across the Governance and Parks, Sport and Recreation units.

The scale of this co-governance arrangement is unparalleled in Auckland and the resulting unified and cohesive approach to caring for the Maunga has garnered widespread support.

STRATEGIC FRAMEWORK:

TÜPUNA MAUNGA INTEGRATED MANAGEMENT PLAN

The Tūpuna Maunga Integrated Management Plan ("IMP") sets the foundations for how the Tūpuna Maunga are valued, protected, restored, enhanced, and managed in the future with equal consideration and reverence. The IMP established a set of Values for the Tūpuna Maunga which are outlined below.

The IMP was developed in accordance with Section 41 of the Reserves Act to provide for and ensure the use, enjoyment, maintenance, protection, preservation, and development as appropriate for the reserve purposes for which each of the Tūpuna Maunga is classified. This single integrated plan replaces the former separate legacy reserve management plans for the Tūpuna Maunga.

The IMP was approved in 2016 following a public consultation process and are available at www.maunga.nz.

TŪPUNA MAUNGA INTEGRATED MANAGEMENT PLAN STRATEGIES

The Tūpuna Maunga Integrated Management Plan Strategies are the next level of policy development for the Tūpuna Maunga and aim to support the Values and Pathways in the Tūpuna Maunga Integrated Management Plan 2016.

The IMP Strategies was approved in 2019 following a public consultation process and are available at www.maunga.nz.

TŪPUNA MAUNGA VALUES

Within the Tūpuna Maunga Integrated Management Plan, the Tūpuna Maunga Authority has articulated a set of values of the Tūpuna Maunga. The values promote the statutory purpose of the Tūpuna Maunga under section 109 of the Collective Redress Act, where in exercising its powers and functions the Authority must have regard to the spiritual, ancestral, cultural, customary and historical significance of the Tūpuna Maunga to Ngā Mana Whenua.

The values provide a strategic framework to guide the Tūpuna Maunga Authority in making any decision about the Tūpuna Maunga.

The values weave together and give expression to mana whenua and other world views, and the connections and histories in a manner that highlights the way in which these views complement each other and create a richness to the relationship people have with the Tūpuna Maunga and multiple ways in which these relationships are thought of and expressed.

TŪPUNA MAUNGA OPERATIONAL PLAN 2026/27

Each financial year, the Tūpuna Maunga Authority and Council must agree an annual operational plan to provide a framework in which the Council will carry out its functions for the routine management of the Tūpuna Maunga and administered lands for that financial year, under the direction of the Tūpuna Maunga Authority.

The Tūpuna Maunga Operational Plan 2026/27 identifies a number of projects to be delivered or commenced in the coming financial year and the subsequent two financial years. The Tūpuna Maunga Operational Plan 2026/27 also sets out the 10-year work programme and funding envelope confirmed through the Long-term Plan 2024-2034. The budget for 2026/27 and the subsequent years fits within this funding envelope.

PRIORITY PROGRAMMES AND PROJECTS OVER THE NEXT 3 YEARS INCLUDE:

POLICY AND MANAGEMENT

- Develop individual Tūpuna Maunga plans to provide direction on how the Values, Pathways, guidelines and strategies should be reflected on each Tūpuna Maunga.
- Progressing the potential transfer of administration over certain Maunga reserve lands from the Department of Conservation to the Authority, and the potential transfer of the administration of land contiguous to other Tūpuna Maunga.
- Establishment of a compliance programme including a review of current and establishment of appropriate bylaws.
- Development of individual Tūpuna Maunga plans which reflect the Integrated Values and Pathways, overarching guidelines and strategies for each of the Tūpuna Maunga.

HEALING THE MAUNGA

- Protection and restoration of the tihi (summits) including reconfiguring space and provision of cultural infrastructure.

They will also enable a compelling case in a future UNESCO World Heritage bid for the Tūpuna Maunga, which will contribute to a Māori identity that is Auckland's point of difference in the world. The bid for World Heritage status will require a dedicated resource and will continue to be progressed in this financial year in partnership with the Department of Conservation.

Restoration Planting Programme

- 1. Key principles in the Tūpuna Maunga Integrated Management Plan are:
 - A. To highlight the importance of restoring the Tūpuna Maunga with indigenous ecosystems,
 - B. To reintroduce and attract indigenous and culturally appropriate species, and
 - C. To nurture and enhance the living connections between the Tūpuna Maunga and other areas of indigenous biodiversity in Tāmaki Makaurau.
- 2. To reflect these principles, the ongoing restoration programme of planting native plants on the Tūpuna Maunga continues.
- 3. At the end of this planting season, a total of 28,808 plants were planted across the Maunga network between May-September 2025. These plantings are additional to the 224,137 plants already planted over the last 5 years (a total of 252,945 plants). Please note this number is including 1,524 pending planting numbers as of the 15th of September when this report was due, contractor infill plantings are still being carried out to deal with left-over plant stock, therefore the final number may differ when the plantings are completed end of September depending on final delivery numbers and any potential last-minute changes.
- 4. The table below details the total plants planted this year.

- 5. The Maunga were planted with appropriate plant species within the guidance of ecosystem type, site suitability, fire retardant and archaeologically appropriate species.
- 6. Management held four community planting days across the Maunga network; Te Pane o Mataoho / Māngere Mountain and Te Tātua a Riukiuta / Big King, one school planting on Takarunga / Mt Victoria and organisation plantings on Ōhinerau/Mt Hobson and Matukutūruru/Wiri Mountain. The Friends of Maungawhau community group also carried out plantings on Maungawhau/Mt Eden provided by the Tūpuna Maunga Authority during the planting season.
- 7. All planting dates including back-up dates were best aligned with the Maramataka. Some of the original planting days had to be changed due to wet weather but were still aligned with the Maramataka.
- 8. Tūpuna Maunga Management staff hosted all planting days, welcoming volunteers and providing a tutorial for first-time planters. Each planting day concluded with a barbecue or small kai. In total, management had over 240 community registrations from individuals eager to participate in planting on the Tūpuna Maunga. School planting days involved 55 students from Devonport Primary School. Additionally, over 45 staff members from various teams within Auckland Council took part in organisational planting days.
- For health and safety reasons, there are areas on Maunga where planting could only be undertaken using specialist contractors with the right qualifications and equipment to undertake the work.
- 10. The multi-year planting programme will continue in 2025 and onwards.

Next steps

- 11. Management will continue with the ongoing restoration programme including planting maintenance, monitoring and reporting requirements.
- 12. Undertake planting site visits on Maunga, develop planting plans and schedule plant preparations.
- 13. Management will engage with nurseries, including those led by Mana Whenua, to supply plants for the 2026 planting season.

Tūpuna Maunga Fauna Monitoring Update

Fauna Monitoring Programme

- 1. Key principles in the Tūpuna Maunga Integrated Management Plan relevant to fauna monitoring are:
 - A. To highlight the importance of restoring the Tūpuna Maunga with indigenous ecosystems,
 - B. To reintroduce and attract indigenous and culturally appropriate species, and
 - C. To nurture and enhance the living connections between the Tūpuna Maunga and other areas of indigenous biodiversity in Tāmaki Makaurau.
 - D. Develop a baseline database and inventory of the physical values of each Tūpuna Maunga
- 2. To reflect these principles and with the influx of budget from the Jobs of Nature programme intensive fauna monitoring of birds, bats and lizards was carried out across the Maunga network from April 2024 May 2025.
- 3. This provides a baseline database enabling an assessment of the effectiveness of restoration efforts carried out on the Maunga such as pest plant and animal control and vegetation restoration. This also provided training opportunities for kaimahi involved with the Jobs for Nature programme.
- 4. Results from monitoring of this scale can help direct ongoing management and restoration efforts on the Maunga.

Lizard Monitoring

- 5. Intensive lizard monitoring was carried out across the Maunga network by Wildlands Consultants Ltd and the Tūpuna Maunga Authority from September 2024 May 2025.
- 6. Previous lizard monitoring had been done on a few of the Maunga; however, this was often small scale and specific to consent conditions for large scale CAPEX projects. The monitoring carried out during the 2024/2025 monitoring season was the first large scale lizard monitoring project with the aim to provide baseline data on current lizard populations as well setting up a replicable technique for ongoing monitoring to help determine the success of the ecological restoration for native lizards throughout the Maunga.
- 7. Methodologies chosen to be utilised on the Maunga were those that had proven effective in the past, those that are the least destructive to the Maunga, usable in archaeologically significant areas (no digging) and those that can be carried out within areas readily used by the public. These methodologies included Artificial Cover Objects (ACOs), Funnel trapping and hand searching. All works were carried out by knowledgeable and experienced herpetologists who hold the necessary Wildlife Act Permits.

8. This monitoring determined the presence of native lizards across all 14 of the Maunga, primarily copper skinks (*Oligosoma aeneum;* At Risk - Declining) and ornate skinks (*Oligosoma ornatum*; At Risk - Declining). On some of the Maunga only one of the species was found and on others both were present. The table below outlines the general findings across the Maunga network.

9. The monitoring results show a low population size of copper skinks on Ōhuiarangi, Te Tātua a Riukiuta, Maungauika, Ōhinerau, Te Pane o Mataoho, Ōwairaka, Pukewīwī and Matukutūruru, however presence has been confirmed for the first time on many of these Maunga. Only a few Maunga had ornate skinks picked up during the monitoring, low population sizes seem to occur on Maungawhau and Takarunga, however moderate population sizes seem to occur on Maungauika and Te Pane o Mataoho. Ōtāhuhu, Maungawhau, Maungakiekie, Te Kōpuke and Maungarei appear to have moderate size populations of copper skinks. During the monitoring it was determined that the hand searching methodology resulted in detection of more individuals, and therefore the most effective methodology. Even when low numbers are found detections do indicate that viable populations are likely present on all 14 Maunga.

- 10. These surveys have provided a valuable baseline dataset, further work will be required to monitor changes over time repeating the methodology used here as these species are cryptic and long-lived, so it takes time to see substantial changes within populations. With future monitoring it is suggested a selection of Maunga are subject to targeted surveys where it is likely that enough individuals will be captured to collect robust data such as Ōtāhuhu, Maungawhau, Maungauika, Te Pane o Mataoho and Te Kōpuke. Furthermore, 'hotspots' can be targeted where highest numbers of lizards were found during the 2024/2025 surveys to also provide a more robust data set.
- 11. The findings from this monitoring session have already provided guidance on future restoration efforts on the Maunga, for instance more focussed mouse control has been established on Te Pane o Mataoho and Ōwairaka to provide further protection for native lizard species. Due to the size of Te Kōpuke and the number of native lizards found there are plans in place to try and focus any future vegetation restoration plans on this particular Maunga towards lizard friendly species and try to restore the vegetation within the lizard 'hotspots' identified during monitoring to enhance current habitat.
- 12. The Tūpuna Maunga Authority will aim to repeat lizard monitoring every 3 years with adjustments where necessary to provide robust data sets. Methodologies such as funnel trapping may be trialled on more Maunga during the upcoming monitoring such as Matukutūruru in preparation for the potential instalment of a predator proof fence as this Maunga has the potential to be a native lizard sanctuary. No monitoring for arboreal gecko species occurred during this monitoring period as appropriate habitat is limited across the Maunga network, however some Maunga such as Maungawhau and Te Pane o Mataoho contain potentially suitable habitat, and the aim is to carry out some gecko monitoring this upcoming season Sept 2025 May 2026.

Bat Monitoring

- 13. The Tūpuna Maunga Authority carried out surveys for long-tailed bats (*Chalinolobus tuberculatus;* Threatened-Nationally Critical) with Acoustic Bat Monitors (ABMs) on all 14 of the Maunga across Tāmaki, with the assistance of Tonkin + Taylor.
- 14. One survey was carried out by Tonkin + Taylor in April 2024, and a repeated survey was carried out by The Tūpuna Maunga Authority in December-January 2024-2025 and February-March 2025.
- 15. This species is known to occur within the wider Auckland Region, but little is known about their presence with the Auckland Isthmus.
- 16. According to Auckland Council RURU and Department of Conservation a known bat record occurs within approx. 3.8km of Matukutūruru, this is currently the closest record to one of the 14 Maunga managed by the Tūpuna Maunga Authority.
- 17. Forty-two ABMs were deployed across the 14 Tūpuna Maunga, placement of these were based on the locations of ABMs during the April 2024 survey carried out by Tonkin + Taylor. Each ABM was placed in mature native and exotic trees that were either potential bat roost trees or near potential bat flyways used for commuting and foraging.
- 18. During the survey carried out by Tonkin + Taylor in April 2024 no bats were detected on any of the 42 ABMs deployed during the survey period.
- 19. In the first survey carried out from December January by the Tūpuna Maunga Authority potential bat activity was detected at Takarunga/Mt Victoria on the night of the 26th of December with 36 potential passes between 10:21pm and 4:01am. Considering the location of the ABM in relation to the long-tailed bat distribution the nearest long-tailed bat record is in Mairangi Bay approximately 10km away. Takarunga is 5km away from Rangitoto, though no bat surveys appear to have been carried out on Rangitoto if bats are present their populations may have increased since the island became pest free in 2011, Takarunga is less than 5km from the Rangitoto shoreline and long-tailed bats are known to forage over water bodies greater than this.

- 20. Bat activity was not recorded at any of the other Maunga, often insect and rodent activity was detected.
- 21. Very little bat activity was detected across the three surveys carried out from April 2024 March 2025, it is likely that effects caused by unmitigated lighting at night, noise disturbance from the urban nature of the area and habitat fragmentation may impact the likelihood of bats frequenting the Maunga.
- 22. Many of the Maunga contain no artificial lighting and limited noise disturbances as well as providing corridors and areas of potential roosting, commuting and foraging habitat for native bats. Some of the Maunga do occur within 10km of known long-tailed bat populations such as those occurring within the Waitakere and Hunua Ranges. Therefore, there is a possibility that the Maunga throughout Tāmaki may be utilised by native bats.
- 23. It is recommended that lighting within and around the Tūpuna Maunga is upgraded to bat sensitive lighting and more strategic work on green networks is done to promote bat corridors throughout the Auckland Isthmus. Existing habitat on the Maunga can be further enhanced through native plantings to provide future potential roosting habitat as well as food sources for bats.
- 24. In order to draw any long-term conclusions from this baseline monitoring a long-term yearly monitoring should be carried out across the Maunga network to better understand the absence and presence of bats within Tāmaki. It is recommended that bat monitoring should be undertaken at various times through the bat season (1 October to 30th April) and across years for comparison. Where it may be difficult to fund and manage this level of monitoring it is recommended that a minimum of one survey should be carried out between 1st October to 30th April every year.

Bird Monitoring

- 25. Bird monitoring has been undertaken for several years across a selection of Maunga within Tāmaki. Maunga may support ecologically significant populations of non-native and native avian species and so are potential areas of special interest within the urban environment.
- 26. Nine Maunga were originally chosen as study sites based on the interest of the Auckland Council in measuring the biodiversity values of the Tūpuna Maunga reserves. Resources to date have only allowed for these nine of the 14 reserves to be surveyed. The sites were chosen in terms of their potential to support indigenous bird species as they were the largest reserves and also contained the greatest area of forest, tree land and/or scrub habitats.
- 27. A total of 47 bird-surveying stations were established across the nine Maunga. The methodology utilised was 10-minute bird counts where within the first 5 minutes every bird detected either visually or audibly was recorded and the second 5 minutes only species not detected in the first 5 minutes were recorded. Three 10-minute bird counts are conducted at every surveying station across January and February 2025.
- 28. The table below outlines the survey findings from January and February 2025 across the nine Maunga surveyed; Maungawhau, Te Tātua a Riukiuta, Pukewīwī, Ōhinerau, Maungakiekie, Ōtāhuhu, Ōwairaka, Takarunga and Maungarei.

- 29. 12 native/endemic species and 16 introduced species were found during the 2025 bird surveys across the nine Maunga. The majority of native/endemic species found have a conservation status of Not Threatened, however Red-Billed Gulls were detected on Maungawhau and this is a declining species rarely found inland. The native/endemic species detected the most was silvereyes and tui species critical for maintaining healthy ecosystems as they are important pollinators and dispersers, kererū are also important dispersers of larger native tree fruits and these are also found on the Maunga. House sparrows and common mynas were the most common introduced species found during the survey.
- 30. The high relative abundance of species like silvereye and tui can suggest that the Maunga continue to retain some remnants of their formal ecological functions the dispersal, pollination and recruitment of native plants by native birds. Some of the more common introduced species often found on the Maunga tend to favour open habitat/pastureland reflecting the large amount of this habitat commonly found on the Maunga.
- 31. Findings from these surveys show the Maunga containing important biodiversity which will benefit from continued and intensive restoration projects. Future vegetation restoration of the Maunga bringing in more native bush blocks may support an increase in the proportion of native/endemic to introduced bird species. Vegetation restoration on the Maunga will increase native plants and forest available for foraging and nesting. The native bird species found on the Maunga can guide the native plant species choices to continue to assist in the dispersal of these particular species through the Maunga and Tāmaki.
- 32. This survey and previous surveys have shown the continued high presence of common myna, which are classified as a pest in the current Auckland Council regional pest management plan as they compete with and cause harm to native/endemic species by preying on eggs and chicks, taking over nest sites and disrupting territories. These findings encourage investigating myna eradication programmes as sites where eradication has taken place have shown significant increases in native bird species.
- 33. Future monitoring will be continued throughout the Maunga network on a yearly basis in January and February, and the methodology will be extended to the remaining 5 Maunga previously not surveyed. Bird monitoring results can be a very good indicator of the effectiveness of vegetation restoration and pest animal control across the Maunga.
- 34. Outside of this 10-minute bird count surveys ruru/morepork have been noted to occur on the Maunga and currently ruru nest boxes built and provided by One Tree Hill college are being established on a select few Maunga where ruru have so far been detected (Maungawhau, Maungakiekie, Pukewīwī, Te Tātua a Riukiuta and Takarunga). These nest boxes have been established to enhance nesting habitat availability for ruru, further monitoring will be carried out to determine other Maunga that may contain ruru and if more nest boxes can be sourced these will hopefully be installed on other Maunga. The installed ruru nest boxes will be checked and maintained yearly to provide data on breeding pairs within the Maunga.

Next Steps

- 35. Intensive native fauna monitoring across the Maunga network has provided valuable baseline data sets which can help guide restoration efforts.
- 36. Intensive monitoring of birds, bats and lizards will be continued across all 14 Maunga to help assess the effectiveness of the restoration efforts on the Maunga.
- 37. Pest plant and animal control as well as vegetation restoration will continue on the Maunga and will benefit all native fauna, vegetation restoration in particular may be focussed on species that provide habitat for the native fauna species found on the Maunga during survey efforts.

Purpose	The purpose of this report is to provide an overview of the Jobs for Nature contract within the conservation space October 2021-April 2025.

Jobs for Nature Background

- 1. As part of the COVID-19 recovery package Jobs for Nature project provided 1.185 billion dollar programme that managed funding across multiple government agencies to benefit the environment, people and the regions.
- 2. The Jobs for Nature contract between the Tūpuna Maunga Authority and the Department of Conservation was signed in October 2021 and finished in April 2025 for \$3 million.
- 3. The project was called 'Te Mauri Hauropi o Ngā Tūpuna Maunga' and was designed to support the landscape scale restoration of Auckland's Tūpuna Maunga (ancestral mountains) through pest and weed control. The project would support the removal of pest animals and plants that have significant impacts on the ecology of the Maunga, as well as ongoing vegetation restoration work to establish ecological corridors for native fauna. The aim was to upskill kaimahi in the conservation space and provide education on the values of the Tūpuna Maunga as well as support ongoing employment and training.
- 4. The Authority has worked with four different suppliers throughout the Jobs for Nature (JFN) contract NZ Enviro Ltd, Te Ngahere Ltd, Wildland Consultants Ltd and Rahopara Parks and Gardens Ltd.
- 5. Key principles in the Tūpuna Maunga Integrated Management Plan that this contract is related to are:
 - a. Nurture and enhance the living connections between the Tūpuna Maunga and other areas of indigenous biodiversity in Tāmaki Makaurau.
 - b. Restore areas of the Tūpuna Maunga with indigenous ecosystems, reintroduce and attract indigenous species and culturally appropriate species.
 - c. Removing exotic pest plants and pest animals aligned with values being protected on each Maunga.
 - d. Protect the values identified on each Maunga with best practice methodologies implemented.
 - e. Researching alternatives to toxins on the Maunga and gradual phasing out of herbicides and pesticides.
 - f. Engaging communities volunteers and neighbours in ensuring the biosecurity measures are in place.

Jobs for Nature Achievements

- Approximately 29 full-time employees (FTEs) were employed over the course of the contract, meeting the programme's objective to create job opportunities as part of the COVID-19 recovery.
- 7. Training opportunities provided were:
 - a. Pest plant and animal control
 - b. Native flora and fauna monitoring and identification
 - Health and Safety training
 - d. Kaitiakitanga, Te Reo Māori, Tikanga Māori
 - e. Community engagement
 - f. Machinery and equipment use
 - g. Team Leadership
- 8. Environmental outcomes achieved throughout the project:
 - a. Over 230ha of possum, rat and mustelid control.
 - b. Over 147ha of other pest animal control
 - c. Over 180ha of pest plant control
 - d. 1.42ha of wetland restored
 - e. Approximately 101,000 native plants planted
 - f. Approximately 7ha of non-wetland areas restored
 - g. Fauna and flora monitoring across all the Maunga
- Procurement opportunities with iwi suppliers were created through the Jobs for Nature (JFN) funding. For example, Ngāti Whātua Ōrākei Whai Māia nursery (Pourewa) supplied a large volume of plants used across multiple Maunga during the contract period.
- 10. Additional funding enabled increased of pest control efforts to 30-40 hours per week, expansion of pest control networks and target species including regional pest plants, exotic species and problematic weeds, providing exciting employment and training opportunities that kaimahi may not typically have access to.
- 11. Provided assistance to local volunteer and community restoration groups working on the Maunga e.g. Jobs for Nature kaimahi supported Restoring Takarunga Hauraki Charitable Trust with pest animal control on Maungauika/North Head and Takarunga/Mt Victoria.
- 12. Allowed the Tūpuna Maunga Authority to invest more resources into existing biodiversity and biosecurity strategies that would not have been achievable within the standard budget.

Conservation Next Steps

- 13. Two of the suppliers from Jobs for Nature have signed on to new contracts with the Tūpuna Maunga Authority to continue pest plant and animal control as well as vegetation restoration across all the Maunga. Keeping these suppliers on was due to the quality of mahi shown during the Jobs for Nature contract and their familiarity with the Maunga.
- 14. This injection of funding over the past three years has help achieved essential restoration goals and allowed all the Maunga to be at a good baseline that we can now aim to maintain with future budget that will be substantially less.

- 15. This project provided the opportunity for baseline fauna monitoring that hadn't been done to this scale in the past and this can now be maintained for the foreseeable future allowing us to determine to what extent the biodiversity and biosecurity strategies are working.
- 16. A big focus within the conservation space now that Jobs for Nature has provided the setup of necessary baseline data and equipment is to bring more volunteer and community support onto the Maunga working within the biosecurity and biodiversity space.

Background

- 1. The Tūpuna Maunga Research Policy was adopted at Hui 71 (14 February 2022).
- 2. Alongside the policy, the Tūpuna Maunga Authority agreed to make up to \$10,000 available annually to contribute to research projects deemed to be beneficial for the Tūpuna Maunga.
- 3. This funding can be allocated to one or more applicants.
- 4. Aims of the scholarship include:
 - a. provide opportunities for public to engage with the maunga as a space of learning and discovery,
 - b. support student learning, and
 - c. help gather detailed, site-specific information which supports effective management of the maunga.
- 5. The allocation of scholarship funding occurs within the criteria of the Research Policy.

Statutory context

- 6. All decisions of the Authority must consider the legislative and policy framework.
- 7. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
- 8. The Tūpuna Maunga Authority's Integrated Management Plan was unanimously adopted (Mana Whenua and Auckland Council members) by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.
- 9. The Tūpuna Maunga Authority (Mana Whenua and Auckland Council members) unanimously adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies outline the strategic direction with regards to education, biodiversity, design, recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the maunga.

- 10. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.
- 11. Within the monitoring strategy, mechanisms are outlined which enable the education strategy to be implemented. This includes creation of a list of research projects for tertiary students to undertake as part of their qualifications.

Overview of scholarship round

- 12. The scholarship application period was from 30 June 2025 to 31 August 2025.
- 13. Management created a project plan and communications plan to manage the process of the scholarship programme. As part of the comprehensive communications plan management communicated with mana whenua and other key stakeholders. Management further communicated the scholarship through the maunga.nz website, the Love Your Maunga social media channels and targeted promotion to stakeholders and interested parties.
- 14. Four applications were completed and received during the grant round. As agreed by the Authority at Hui 71, the scholarship application was initially reviewed by management to determine its suitability and alignment with Tūpuna Maunga values.
- 15. An internal evaluation panel and process were established to review and assess applications. The panel, made up of five kaimahi, individually evaluated each submission using an evaluation form. The evaluation approach was supported by a tiered marking system based on key criteria aligned to the Integrated Management Plan, Strategies, and Values.
- 16. The panel met to share their insights, based on the aligned criteria and used consensus decision-making in recommending the successful applications and the corresponding funding amounts in line with the marking.

Next steps

17. If the Authority approves the scholarships granted, management will inform all applicants of the outcome. Management will then, work alongside the successful applicants to ensure the research is undertaken successfully, and in accordance with the permitting conditions.
