Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014

109 Functions and powers

- (1) The Maunga Authority has the powers and functions conferred on it by or under this Act or any other enactment.
- (2) In exercising its powers and carrying out its functions in relation to the maunga, the Maunga Authority must have regard to—
 - (a) the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau; and
 - (b) section 41(2).
- (3) In exercising its powers and carrying out its functions in relation to the administered lands, the Maunga Authority must have regard to the spiritual, ancestral, cultural, customary, and historical significance of the administered lands to Ngā Mana Whenua o Tāmaki Makaurau.

[Emphasis added]

41 Maunga must remain as reserves vested in trustee

- (1) This section applies to each maunga once the maunga is—
 - (a) vested in the trustee under subpart 1, 2, or 3 of this Part;and
 - (b) Declared a reserve under any of sections 18 to 29, 33, and 39.
- (2) The maunga is held by the trustee for the common benefit of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

1. Key highlights in this quarter:

- **May/June Planting Days:** The first two community days of the planting season were held at Te Tātua a Riukiuta / Big King and Te Pane o Mataoho / Te Ara Pūeru / Māngere Mountain. The first three school planting days of the season were held at Te Kōpuke / Tītīkōpuke / Mt St John, Tātua a Riukiuta / Big King and Matukutūruru / Wiri Mountain.
- **Installation of wētā motels:** The start of installation of wētā motels on the Maunga to provide ongoing invertebrate monitoring.
- **Conclusion of Research Scholarship 25/26:** With four recipients, this was the largest cohort of researchers supported as part of the Research Scholarship.
- **Mana Whenua guided hīkoi:** Two community hīkoi, delivered by mana whenua tour operator Explore Tāmaki on Maungauika and Takarunga were supported by the Devonport-Takapuna Local Board.
- **Rangatahi engagement:** May Road Primary School visit to Puketāpapa / Pukewīwī and Tāmaki Primary hīkoi with Explore Tāmaki on Maungarei.

2.1 Conservation data.

All biodiversity pest animal data—including trap, bait, and monitoring records—are now captured using the Trap.NZ app and website. This streamlined approach centralises data collection, making it easier to access, manage, and report on outcomes moving forward.

Consistent data reporting over time will support more accurate and conclusive assessments of trends in pest animal populations on the maunga, enabling us to make more informed and effective management decisions

This data is available in the quarterly report, this data is available, and is presented in Attachment A.

The data presented in the table above is from the April 2026 bait pulse and indicates high uptake across the Maunga.

Rat populations typically peak between February and April, and this trend has been reflected in widespread reports of high bait consumption across the region. Consistently elevated bait take suggests the presence of active rat populations on the maunga and/or ongoing reinvasion from surrounding areas. If elevated bait take persists over time, a review of the current pest management strategy will be undertaken, adjusting the control setup if deemed necessary.

Baiting on the Maunga is carried out in accordance with best practice standards, four times a year, in February, April, August, and November. Regularly scheduled monitoring will continue to track trends in pest animal abundance and support informed pest animal management decisions.

Lockable pest control stations are used across the Maunga. These stations are designed to securely house both bait and rat traps, complying with health and safety standards while supporting efficient and targeted pest management.

Note: Maungauika, Takarunga and Matukutūruru have been excluded for this dataset, as there has been a change in delivery model for pest animal control works. As a result, the April bait pulse was not undertaken on these maunga. Pest animal control works have since resumed under a new contract, with baiting completed as part of the August 2026 pulse.

Tūpuna Maunga Planting Update 2026

Purpose

1. To update the Tūpuna Maunga Authority on the 2026 restoration planting programme.

Recommendation

That the Tūpuna Maunga Authority:

- a. tuhi tīpoka / note the report.

Background

Restoration Planting Programme

2. Key principles in the Tūpuna Maunga Integrated Management Plan are:
 - a. To highlight the importance of restoring the Tūpuna Maunga with indigenous ecosystems,
 - b. To reintroduce and attract indigenous and culturally appropriate species, and
 - c. To nurture and enhance the living connections between the Tūpuna Maunga and other areas of indigenous biodiversity in Tāmaki Makaurau.
3. To reflect these principles, the ongoing restoration programme of planting native plants on the Tūpuna Maunga continues.

Statutory Context

4. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau, and that the Tūpuna Maunga are held in trust for Ngā Mana Whenua and the other people of Auckland.
5. Any decision to determine management within a reserve must take into account the legislative and policy framework.
6. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also relevant. The activities of the Scouts are consistent with the reserve classification.
7. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.

8. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.
9. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.

Discussion

10. At the end of this planting season, a total of 34,178 plants were planted across the Maunga network between May-September 2026. These plantings are additional to the 252,945 plants already planted over the last 6 years (a total of 287,123 plants). Please note the total planting number for 2026 may be slightly higher (approx. 200-300 plants) at the end of September due to some contractor infill plantings still to be completed when this report was written.
11. The table below details the total plants planted this year

12. The Maunga were planted with appropriate plant species within the guidance of ecosystem type, site suitability, fire retardant and archaeologically appropriate species.
13. Management held four community planting days across the Maunga network; Te Pane o Mataoho / Māngere Mountain, Te Tātua a Riukiuta / Big King, Te Kōpuke/ Mt St John and Maungarei / Mt Wellington.
14. Five school plantings were carried out across the Maunga network; with Te Kura Kaupapa Māori a rohe o Māngere on Te Pane o Mataoho/ Māngere Mountain, Three Kings School on Te Tātua a Riukiuta / Big King, Dilworth school on Te Kōpuke / Mt St John, Ruapōtaka Primary School on Maungarei/Mt Wellington and Te Wharekura o Tāmaki ki te Tonga on Matukutūruru / Wiri Mountain.
15. The Friends of Maungawhau and Friends of Te Tātua a Riukiuta community groups carried out plantings on Maungawhau and Te Tātua a Riukiuta with plant supply and support provided by the Authority.
16. Tūpuna Maunga Management staff hosted all planting days, welcoming volunteers and providing a tutorial for first-time planters. Each planting day concluded with a barbecue or small kai.
17. All planting dates including back-up dates were best aligned with The Maramataka.
18. For health and safety reasons, there are areas on Maunga where planting could only be undertaken using specialist contractors.
19. The multi-year planting programme will continue in 2027 and onwards.

Key Highlights

20. The 2026 planting season saw significant growth in participation, community engagement and partner involvement across the Tūpuna Maunga network.

21. Community planting days attracted 519 volunteers across the four Maunga, including record attendance at Te Pane o Mataoho / Te Ara Pueru / Māngere Mountain (137 volunteers) and Maungarei / Mt Wellington (162 volunteers), an increase from 340 people attending in 2025.
22. School participation was 218 students across the five Maunga in 2026, an increase from 55 students across one planting day in 2025. This season included the Authority's first planting events with Kura Kaupapa Māori.
23. Māori participation increased from 6% to 11% of survey respondents, while Pasifika participation increased from 0% to 7%.
24. Participation was also strong across Asian, Indian and other diverse communities, reflecting the broad appeal of the restoration programme.
25. Survey feedback highlighted biodiversity restoration, mana whenua leadership, cultural learning and community connection as key drivers of participation and satisfaction.

Partnerships

26. The 2026 planting programme was supported by a range of partners including mana whenua, schools, community organisations, contractors and nurseries.
27. Te Ākitai Waiohū provided cultural leadership across planting events through whakatau, karakia and the sharing of mātauranga Māori. Ngāti Paoa participated in the Maungarei / Mt Wellington planting day and expressed interest in developing a kaitiaki rūpū to support future restoration and monitoring activities.
28. The school planting programme was delivered in partnership with Auckland Council's Sustainable Schools team, which supported school engagement and secured an \$8,000 grant from the Toimata Foundation. Additional support from the Parks and Community Facilities Māori Outcomes team enabled greater engagement with Kura Kaupapa Māori.
29. E Tū Rākau provided kai and refreshments at community planting events and supported low-waste objectives through event waste management.
30. Plants were provided from several different nurseries, majority of these were iwi or community run nurseries. Approximately 12,000 plants were sourced from iwi run nurseries – Ngāti Whātua Ōrakei Pourewa Nursery and Makaurau Marae Nursery and the remainder were sourced from Kaipātiki Project, Restoring Takarunga Hauraki and Te Whāngai Trust.
31. The Eastern Bays Songbird Project partnered with the Authority at Maungarei / Mt Wellington to promote backyard trapping initiatives and distributed 30 pest traps to local households, supporting broader biodiversity outcomes beyond the planting programme.

Auckland Archery Lease

Purpose

1. To consider a potential lease to the Auckland Archery Club Lease on Maungakiekie/One Tree Hill.

Recommendation

That the Tūpuna Maunga Authority:

- a. tuku / grant, subject to completion of statutory processes, including public notification under s119 of the Reserves Act 1977, a lease to Auckland Archery Club (Attachment A) subject to the following terms and conditions:
 - i. Term – Five (5) years plus 2x Five (5) Years Right of Renewal, commencing on 1 November 2026.
 - ii. Rent at a market rental as determined by a registered valuer based on final site area measurements and required days of operation.
 - iii. Maunga Outcomes plan be prepared and attached as a schedule to the lease agreement.
 - iv. all other terms and conditions in accordance with Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977 and the Tūpuna Maunga Authority standard form lease agreement.
- b. If required, tāpae / delegate to Co-Chairpersons and deputy chairperson the power to appoint a hearings panel pursuant s 120 of the Reserves Act 1977 to consider and hear any submissions received and make a decision on the lease.
- c. tāpae / delegate to Co-Chairpersons and Deputy Chair the power to execute a lease, including a Maunga Outcomes Plan, with lessee on the terms and conditions set out in resolution.
- d. tāpae /delegate to the Co-Chairpersons and Deputy Chair the power to agree to terms governing the termination arrangements of lessee should they decide not to accept the new lease.

Item 4.3

Background

2. The Auckland Archery Club (the Club) is occupying part of Maungakiekie/One Tree Hill that is a Recreation Reserve. The tenant owns and maintains the buildings that they occupy.
3. At Hui 62 (22 February 2021) the Tupuna Maunga Authority resolved to grant a renewal of lease to the Auckland Archery Club for the initial term of 1 year, this term has ended on 30 November 2023. Archery range is used 5 days, on Tuesdays, Wednesdays, Fridays,

Saturdays, Sundays and on public holidays that fall on a Monday. Archery Club has been on the Maunga since 1946 and they have 460 members.

4. At Hui 101 (4 August 2025) the Tūpuna Maunga Authority resolved reduce archery activity on the Maunga from two sites to one at Maungakiekie / One Tree Hill and negotiate the lease with Auckland Archery.
5. Following the high winds on 1 September 2025, we were advised that one of the large Macrocarpa trees had fallen onto the Auckland Archery Club, causing significant damage to the clubhouse building. The clubhouse is owned by the Auckland Archery Club. The Club's insurance claim has been accepted, and they have received the first settlement.

Statutory Context

6. Any decision to determine management within a reserve must take into account the legislative and policy framework.
7. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also relevant. The activities of the Scouts are consistent with the reserve classification.
8. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the tūpuna maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
9. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.
10. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.

Reserves Act 1977 considerations

11. Section 54 of the Reserves Act 1977 sets out the Authority's powers in relation to leasing on a recreation reserve.
12. There is a requirement to publicly notify an intention to lease land within a Recreation Reserve.
13. Section 53(1) of the Reserves Act allows the Authority to prescribe the games, sports and other activities for public recreation that may take place in any specified part of the Reserve. This section also allows the Authority to grant organisations exclusive use of parts of the reserve for a sporting or recreation purpose.

Item 4.3

Discussion

Leases on Tūpuna Maunga

14. The Tūpuna Maunga o Tāmaki Makaurau Integrated Management Plan (IMP) describes a series of values and pathways that dictate decision-making on leases. The IMP places the health and well-being of the Tūpuna Maunga at the heart of all decisions.
15. Any leasing activity must be consistent with the IMP Tūpuna Maunga values and should actively promote those values. One step is a Maunga Outcomes Plan which forms part of all leases on Tūpuna Maunga.
16. A license to occupy provides for a short-term right to occupy a property for a particular purpose and allows for the use of the site by others outside the prescribed license times. Section 53(1) of the Reserves Act states that an agreement can be entered into for a license, but this does not apply to buildings unless they are of a temporary nature.

Auckland Archery Club

17. Archery is a sport where participants use a bow to shoot arrows at a target. Archery competitions are held at various levels, including local, national, and international events, including the Olympic Games. Archery is a sport that can be practiced by people of all ages, genders, and abilities, including those with disabilities. The Club has 400 members and has been on the Maunga since 1946.
18. The Club have submitted lease application with key points as follows:
 - a. Due to the significant investment (over 800,000) at the beginning of the lease the Club are seeking a new lease for a longer period to allow surety of terms and funding to be secured. Proposed Lease and Licence Areas are in attachment A.
 - b. The Club propose to rebuild in a new location to the beginning of the range clubhouse building (Area A) and add small storage to the end of the range for targets (Area B).
 - c. Archaeological assessment has not identified known archaeological features
 - d. Club propose to increase of the usage days from current 5 to 7. It is expected that current membership will continue to grow as archers seeking this accessibility move over to us from Mountain Green Archery club. To this end the club is already building a new booking system and developing new processes and procedures to facilitate this in a safe, and tightly regulated fashion.
 - e. The Club's Commitments:
 - i. Minimal earthworks and ground disturbance (including stormwater and wastewater solutions)
 - ii. Immediate cessation of works if archaeological material is discovered
 - iii. Collaboration with TMA, mana whenua and Heritage New Zealand.
 - iv. Design and process that respects the significance of Maungakiekie.
19. The Club have completed their Maunga outcomes plan, activities contribute towards the Maunga values, and they collaborate with Tūpuna Maunga team on programmes. The Kōperepere ki te Rangi, Rangatahi ki te Whenua programme is introducing archery experience in Te Reo Māori with Te Kura Kaupapa Māori a Rohe o Māngere. At the centre of this kaupapa are the aspirations of the kura, enhancement and uplifting the mana of our tauira through learning experiences that reflect who they are.

Item 4.3

Additional Lease Conditions

Access

20. The range is accessed from the private Cornwall Park Trust Land. Any use of Cornwall Park land or facilities for servicing and operational purposes requires separate landowner approval from Cornwall Park Trust (i.e. carpark and toilets).

Carparking

21. The Club may use Tūpuna Maunga Authority public carparks, these may be used by the club alongside the members of the public.

Toilets

22. Facilities for the club use are incorporated into the clubhouse design. Medium to large events will require delivery of additional Portaloo's on site. Temporary toilets are to be situated on Tūpuna Maunga Authority boundary.

Landowner approval

23. Should the lease be approved, the Club will be required to obtain landowner approval from Tūpuna Maunga Authority for the clubhouse and shed construction. The approval will set out detailed requirements to be met before, during, and after construction. All requirements will be subject to the prior review and approval of the Kaiwhakahaere Tūpuna Maunga Operations and, where applicable, the Cornwall Park Trust.

Key Terms

Term

24. Given the above context management proposes to offer a lease for the proposed building and storage (Shown as Area A and B in the Attachment A) and a license to occupy for the outdoor range area (Area C in the Attachment A) for a term of 5 years plus 2x 5 years of renewal commencing on 1 November 2026.
25. Operating hours are set out 5 days per week during following times: spring/summer 7am to 9pm and autumn/winter 7am to 6pm.

Rental

26. Rent at a market rental as determined by a registered valuer based on final site area measurements and required days of operation.

Next Steps

27. If a lease is to be offered, management will engage in public notification process.

Purpose

1. To consider the Tūpuna Maunga Research Scholarship grants for 2026/2027.

Recommendation

That the Tūpuna Maunga Authority:

- a. tuhi tīpoka / note the report.
- b. toha / allocate the Tūpuna Maunga Authority Research Scholarship grants for 2026/2027.

Background

2. The Tūpuna Maunga Research Policy was adopted at Hui 71 (14 February 2022).
3. Alongside the policy, the Tūpuna Maunga Authority agreed to make up to \$10,000 available annually to contribute to research projects deemed to be beneficial for the Tūpuna Maunga. This funding can be allocated to one or more applicants.
4. The updated Tūpuna Maunga Research Policy was adopted at Hui 105 (25 May 2026). The updated policy states TMA's willingness to enter in partnerships with value-aligned businesses and organisations for the purpose of funding research on the Tūpuna Maunga.
5. A partnership between TMA and the Māori Education Trust (MET) was approved at Hui 105 (25 May 2026). This partnership increased the overall amount of money within the Tūpuna Maunga Authority Research Scholarship, through MET's commitment to matching TMA's funding for Māori scholarship recipients. This will increase available funding to up to \$20,000 per year, from the 2026/27 round onwards.
6. Aims of the scholarship include:
 - a. provide opportunities for public to engage with the maunga as a space of learning and discovery,
 - b. support student learning, and
 - c. help gather detailed, site-specific information which supports effective management of the maunga.
 - d. The allocation of scholarship funding occurs within the criteria of the Research Policy.

Statutory Context

7. All decisions of the Authority must consider the legislative and policy framework.

8. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
9. 12. Within the monitoring strategy, mechanisms are outlined which enable the education strategy to be implemented. This includes creation of a list of research projects for tertiary students to undertake as part of their qualifications.

Discussion

Overview of scholarship round

13. Management communicated the scholarship through the maunga.nz website, the Love Your Maunga social media channels and targeted promotion to stakeholders and interested parties.
14. The Māori Education Trust communicated the Research Scholarship through their social media channels.
15. A letter communicating the commencement of the scholarship round was sent to mana whenua and members of the Authority on 15 June 2026. A letter communicating the commencement of the scholarship round was sent to other interested parties, including tertiary education organisations on 29 June 2026.
16. The scholarship application period was from 29 June 2026 to 30 August 2026.
17. Nine applications were completed and received during the grant round. Of the nine applications, seven were solely for the research scholarship, and two were for both the research scholarship and the residency.
18. As agreed by the Authority at Hui 71, the scholarship application was initially reviewed by management to determine its suitability and alignment with Tūpuna Maunga values.

19. An internal evaluation panel and process were established to review and assess applications. The panel, made up of four kaimahi, individually evaluated each submission using an evaluation form. The evaluation approach was supported by a tiered marking system based on key criteria aligned to the Integrated Management Plan, Strategies, and Values.
20. The panel met to share their insights and collaboratively decide on the recommended successful applications and the corresponding funding amounts.
21. Due to the partnership with MET, some applicants were also eligible for funding from MET.
22. The panel has recommended that four applications are funded.

Next steps

23. If the Authority approves the scholarships granted, management will inform all applicants of the outcome. Management will then work alongside the successful applicants to ensure the research is undertaken successfully, and in accordance with the permitting conditions.
