*Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014*

*109 Functions and powers*

- (1) The Maunga Authority has the powers and functions conferred on it by or under this Act or any other enactment.
- (2) In exercising its powers and carrying out its functions in relation to the maunga, the Maunga Authority must have regard to—
  - (a) the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau; and
  - (b) section 41(2).
- (3) In exercising its powers and carrying out its functions in relation to the administered lands, the Maunga Authority must have regard to the spiritual, ancestral, cultural, customary, and historical significance of the administered lands to Ngā Mana Whenua o Tāmaki Makaurau.

[Emphasis added]

*41 Maunga must remain as reserves vested in trustee*

- (1) This section applies to each maunga once the maunga is—
  - (a) vested in the trustee under subpart 1, 2, or 3 of this Part;and
  - (b) declared a reserve under any of sections 18 to 29, 33, and 39.
- (2) The maunga is held by the trustee for the common benefit of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

## COVID-19 update

<b>Purpose</b>	To provide an update on Management's response to Coronavirus (COVID-19) since going into alert level 4
<b>Recommendations</b>	That the Tūpuna Maunga Authority: a) <b>note</b> the steps that Management have taken moving into Covid-19 alert levels 4 and 3

## Background

1. On 17 August 2021, the Prime Minister announced that New Zealand / Aotearoa would move to COVID-19 alert level 4 (the highest level of restrictions) Alert level 4. This meant that people were only allowed to leave their residences to obtain essential services or to undertake exercise locally while remaining in their isolation 'bubbles'. The government also only allowed essential services to be undertaken.
2. On 20 September 2021, the Prime Minister announced that Tāmaki Makaurau / Auckland would move to alert level 3 from 11.59pm Tuesday 21 August 2021.
3. At each alert level, Management reviews the work programme to ensure that only essential services are to be carried out. Management also peer reviews this work with the Council family to ensure there is consistency with other reserves administered by council.

## Management actions at level 4

4. In preparation to go into level 4 the following work was undertaken:
  - All Tūpuna Maunga vehicle entrance gates were closed including automated gate access to the tihi of Maunga. Pedestrian access was not restricted.
  - COVID-19 signage advising of restrictions were put in place at key spots including gates, toilets, playgrounds and water fountains
  - Locking or removal of playground equipment such as swings, flying foxes and push-trains
  - Water fountains were turned off and covered.
  - The Māngere War Memorial Hall was closed
  - All staff were sent home to work.
5. The following work continued across the Maunga network as they were deemed essential services:
  - Monitoring and mowing firebreaks
  - Daily litter runs
  - Security patrols and any necessary compliance work.
  - Monitoring of illegal dumpings and vandalism.

6. The following work was put on hold until the alert levels allow non-essential activity:
  - The capital work delivery programme including track works at Mangere, Te Tātua and Maungauika
  - Animal and weed control
  - Garden maintenance
  - Road maintenance (unless for emergency works)
  - Tree maintenance (unless for emergency works)
  - Building maintenance (unless for emergency works).
7. During the lockdown period staff carried on with desktop work that could be undertaken from their homes. This work including progressing capital works planning, programme and financial planning and engaging with relevant stakeholders including lease holders and other agencies.
8. Management also received reports of some undesirable behaviour on the Maunga throughout level 4 and commenced a public information campaign encouraging people to treat the Maunga respectfully. This has been publicised on the [Tūpuna Maunga website](#), through Our Auckland, the Love Your Maunga Facebook and Instagram pages and directly with our partners and stakeholders.

### Operations under Level 3

9. Under level 3, the following restrictions on the Maunga will remain in place
  - Vehicle access to the Maunga will remain restricted.
  - Toilet facilities will remain closed
  - Playgrounds will remain closed
  - Māngere War Memorial will remain closed
  - Sports field bookings are on hold
  - Event permit processing is on hold
10. Level 3 does offer the opportunity to reactivate work on the Tūpuna Maunga and management will be undertaking the following during level 3, including:
  - Recommencing the capital works programme including continuing track works at Mangere, Te Tātua and Maungauika and starting works at Te Kōpuke and Maungarei.
  - Resume renovations work to ensure sport fields continue to be maintained to a good standard.
  - Resuming the pest control programme across the network
  - Check in with lease holders to get updates from them on how they are placed and what support they require.
11. All operational work that resumes will be approved by management prior to beginning and contractors must be able to show that they have safe operating procedures in place that meet COVID-19 / Ministry of Health guidelines. Management have undertaken a pre-commencement audit of their COVID-19 Response plan and will be undertaking regular audits throughout level 3 lockdown.

## Northern School Cycling Tour and North Shore Marathon event permits

<b>Purpose</b>	The purpose of this report is to consider multi-year (2021-2026) event permits for:  a) The Northern School Cycling Tour; and  b) The North Shore Marathon.
<b>Recommendations</b>	That the Tūpuna Maunga Authority:  a) <b>resolve</b> to grant a five year permit to the Northern School Cycling Tour and the North Shore Marathon to hold their events at the respective locations, Maungarei and Maungauika, subject to usual Authority conditions and such further conditions that may become necessary.  b) <b>note</b> management will work with the respective groups to establish dates for the future events and monitor and report on each of the events when they occur.

### Background

1. The Tūpuna Maunga Events Rōpū has in previous years approved applications for both: the Northern School Cycling Tour event, held on Maungarei, and the North Shore Marathon, held on Maungauika.
2. Management recommends that each of the applicants be granted a five-year permit from 2021.

### Statutory and other considerations

3. This paper relates to Maungarei / Mt Wellington (Local Purpose and Recreation reserves) and Maungauika / North Head (Historic reserve).
4. Clause 2.3 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Deed 2012 states:  
“2.3 The Tāmaki Makaurau collective legislation will, on the terms provided by section 43 of the draft bill, direct the Registrar-General to record on any computer freehold register for each maunga that the iwi and hapū of Ngā Mana Whenua o Tāmaki Makaurau specified for that maunga in table 1 of part 3 of the property redress schedule have spiritual, ancestral, cultural, customary and historical interests in the maunga.”
5. The Collective Deed Property Redress Schedule contains the table referred to in clause 2.3, and the iwi/hapū having spiritual, ancestral, cultural, customary and historical interests in the Maunga are as follows:

6. Any decision to determine management within a reserve must take into account the legislative and policy framework.
7. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also relevant.
8. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau and that the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.
9. The Tūpuna Maunga Authority's Integrated Management Plan (IMP) was adopted by the Authority in terms of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and the Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga. The primary focus of the IMP is to protect the health and well-being of the Tūpuna Maunga.
10. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
11. The Tūpuna Maunga are within the catchments that support the Hauraki Gulf. The purpose of the Hauraki Gulf Marine Park Act 2000, among other matters, is to "recognise the historic, traditional, cultural, and spiritual relationship of the tangata whenua with the Hauraki Gulf".

### Proposed Activity

12. The Northern School Cycling Tour is a cycling competition involving the top secondary school cyclists from around the country. The event has been held for the last 24 years. The event is usually split over two days, with one component, the 'hill climb' taking place on Mountain Road, Maungarei.

13. The North Shore Marathon is an annual “fun, friendly and relaxed Marathon, Half Marathon, Quarter Marathon, 5km Fun Run & Walk, and Kids Mini Marathon for beginners through to seasoned runners.” Part of the course includes Maungauika.

### **Access Requirements**

14. The Northern School Cycling Tour requires Mountain Road closures, and gate access for gear set-up and an ambulance.
15. The North Shore Marathon requires the closure of Takarunga Road, as well as gate access for set-up.

### **Mana Whenua Feedback**

16. Mana Whenua have been engaged on each of the applications by the respective groups. To date there has only been positive feedback from Mana Whenua supporting each of the events to 2021.

### **Monitoring and Compliance**

17. Note that the management team will work with these groups annually to monitor and report on their events.

### **Event Policy Considerations**

18. In accordance with the Delegation and Mana Whenua Consultation Thresholds both the Northern School Cycling Tour and the North Shore Marathon are considered medium events. Medium events are described as:

Events that:

- involve more than 100 people on: Tahaki Reserve on Maungawhau/Mt Eden; the area between the Stardome Observatory and Manukau Road on Maungakiekie/One Tree Hill; and the sports fields on Ōwairaka /Te Ahi-kā-a-Rakatuara/Mt Albert, Ōhūiarangi/Pigeon Mountain, Pukewīwī/Puketāpapa/Mt Roskill and Māngere Mountain or involve more than 50 people on all other locations
- are for more than 4 hours
- trigger other consent requirements
- involve road closures or ticketing
- have potential to have a more than minor impact on the reserve values and infrastructure, or
- are likely to have a more than minor disruption to the park operations, park visitors and/or neighbouring properties.

Tournaments on sportsfields which:

- Involve 500 or more people
- Operate outside the hours 7.00 am -7.00 pm
- Requires a special liquor licence
- Involve commercial activities outside of the clubroom facility, or
- Involve road closures or parking restrictions.

Filming that:

- has up to 30 crew and 1-20 talent
- is for more than 4 hours
- has no more than 6 trucks
- has small unit base/catering area
- has minimal structures and equipment
- has minimal temporary traffic management,

- has potential to have a more than minor impact on the reserve values and infrastructure,
  - has no inappropriate content; or
  - is likely to have a more than minor disruption to the park operations, park visitors and/or neighbouring properties.
- Any activity where there is or is likely to be reasonable public or iwi interest, e.g., any activity that has content related to the Ngā Mana Whenua o Tāmaki Makaurau Collective Settlement Act 2014, the Tūpuna Maunga o Tāmaki Makaurau Authority and mana whenua's stories. Any activity that is more than a one-off activity or a request for a multi-year approval for annual events.
19. Typically, the Tūpuna Maunga Event Rōpū can approve medium events. However, the Event Rōpū may refer multi-year events to the full authority for their consideration.
20. In accordance with the Fees Schedule for Activities on the Tūpuna Maunga, the Northern School Cycling Tour pay an application and half day location fee in the 'Community' group category, and the 'Filming and Events (Medium) A' fees structure.
21. In accordance with the Fees Schedule for Activities on the Tūpuna Maunga, the North Shore Marathon pay an application and half day location fee in the 'Commercial' group category, and the 'Filming and Events (Medium) B' fees structure.

## Proposed Conditions

22. Management have considered these applications and do not believe there will be any negative impacts on the Maunga.
23. Management proposes the following conditions for the Northern School Cycling Tour:
- The Applicant will provide a Health and Safety Plan.
  - The Tūpuna Maunga are Alcohol and Smoke free spaces. Alcohol and Smoking is NOT permitted at all time during this activity.
  - The Applicant must provide a waste management plan and ensure that no rubbish is left on the Maunga.
  - A code will be supplied for access to the tihi. No more than three vehicles will be able to access the tihi. the Applicant will provide the licence plates of the three vehicles.
  - All ezi ups must be weighted rather than pegged.
  - All participants must only run on existing pathways.
  - Public access to the maunga/reserve must be made available at all times during the event.
  - Public acknowledgement of the Tūpuna Maunga Authority and Ngā Mana Whenua o Tāmaki Makaurau for allowing the event to occur.
  - The Event Organiser is liable for remedial works including dead grass that may occur as a result of the event. All re-establishment works will be fit for purpose and only ensure the asset is re-instated to the same condition prior to the event.
  - The organiser shall ensure that nothing is fixed, hung or otherwise attached to any features of the Maunga (eg. trees, street furniture, lamp-posts, etc.) without the prior consent of the Maunga Authority or its delegate.
  - The organiser must produce a travel plan to demonstrate how they will mitigate traffic congestion.

- As per the portaloo requirement calculator, 9 portaloos are required for this event and all portaloos are to be placed on Mountain Road and Gollan Road.
- Event signage must be installed at both the entrance and exits to the Maunga and surrounding streets prior to the road closure to inform locals and visitors of the closures and event activity.
- All communication, signage and documentation is to use the formally recognised ancestral names of the Maunga.

24. Management proposes the following conditions for the North Shore Marathon:

- The Applicant will provide a Health and Safety Plan.
- The Tūpuna Maunga are Alcohol and Smoke free spaces. Alcohol and Smoking is NOT permitted at all time during this activity.
- The Applicant must provide a waste management plan and ensure that no rubbish is left on the Maunga.
- All communication, signage and documentation is to use the formally recognised ancestral names of the Maunga.
- The course route will be approved by the Tūpuna Maunga Manager to ensure no damage to sites of significance will occur.
- The event organiser to ensure that participants remain on formed tracks at all times and that the course route is well marked.
- Public access to the Maunga/reserve must be made available at all times during the event.
- NO structures are supported as part of this event i.e. marquees, tents, gazebo's.
- The Event Organiser is liable for remedial works including dead grass that may occur as a result of the event. All re-establishment works will be fit for purpose and only ensure the asset is re-instated to the same condition prior to the event.
- Public acknowledgement of the Tūpuna Maunga Authority and Ngā Mana Whenua o Tāmaki Makaurau for allowing the event to occur.
- The organiser shall ensure that nothing is fixed, hung or otherwise attached to any features of the Maunga (eg. trees, street furniture, lamp-posts, etc.) without the prior consent of the Maunga Authority or its delegate.
- The organiser must produce a travel plan to demonstrate how they will mitigate traffic congestion.

### Next steps

25. If the Tūpuna Maunga Authority resolves to approve these events, Management will work with the event organisers to finalise the event dates.

26. Management will continue to monitor the events and report back to the Tūpuna Maunga Authority through the Events Register.

## Guy Fawkes Response Plan

<b>Purpose</b>	The purpose of this report is to outline the proposed approach to protecting the Tūpuna Maunga during the 2021 Guy Fawkes period.
<b>Recommendations</b>	That the Tūpuna Maunga Authority: a) <b>note</b> the protection measures for the Tūpuna Maunga during the 2021 Guy Fawkes period as set out in the report.

## Background

1. Fireworks are the number one cause of fires on the Tūpuna Maunga. At Hui 22 (21 November 2016) following further fireworks fires on the Maunga, the Authority formally opposed the use of fireworks on the Tūpuna Maunga.
2. On 5 November 2019, two large fires were started on Maungawhau and Maungarei as a direct result of fireworks. This resulted in the Tūpuna Maunga Authority publicly declaring that the Maunga will be closed during the fireworks period until such a time as the Government bans the sale of fireworks to the public.
3. In November 2019, several members of Auckland Council made a submission to parliament seeking a ban on the sales of fireworks to the public. Councillor Cathy Casey, in her capacity as a Ward Councillor for the Albert/Eden ward, was amongst council members who made the submission. Their submission was supported by the Tūpuna Maunga Authority.
4. In August 2020, the Parliamentary Governance and Administration Select Committee decided not to ban the sale of fireworks to the public. The Chairperson of the Tūpuna Maunga Authority then wrote to the Prime Minister expressing disappointment in the decision of the select committee.
5. If there was any doubt about the need for proactive protection of the Maunga, yet another fire occurred on 7 October 2020 at Maungarei – caused by fireworks.
6. In 2021, fireworks go on sale from Tuesday 2 November to Guy Fawkes Day Friday 5 November. Management have been planning the Maunga closure for Guy Fawkes week 2021. In previous years the immediate days and weekend following Guy Fawkes has also been a time of increased fire risk.

## Statutory Context

7. Any decision to determine management within a reserve must take into account the legislative and policy framework.
8. Section 109(2) of Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 requires the Authority to have regard to the spiritual, ancestral, cultural, customary, and historical significance of the Maunga to Ngā Mana Whenua o Tāmaki Makaurau and that



the Tūpuna Maunga is held in trust for Ngā Mana Whenua and the other people of Auckland.

9. The Tūpuna Maunga Authority's Integrated Management Plan was adopted by the Authority pursuant to the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 and Reserves Act 1977. The Integrated Management Plan describes a series of "Values" and "Pathways" that guide all activities on the Tūpuna Maunga.
10. The Tūpuna Maunga Authority adopted the Tūpuna Maunga Strategies at Hui 50 on 25 September 2020. The Tūpuna Maunga Strategies are 7 key sections that outline the strategic direction with regards to education, Biodiversity, Tūpuna Maunga design, Recreation, commercial activities and monitoring. Together with the IMP, these strategies inform guide and manage the activities undertaken on the Maunga.
11. The Authority administers the Tūpuna Maunga under the Reserves Act 1977 and pursuant to Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014. The Hauraki Gulf Marine Park Act 2000 is also applicable in relation to Maungauika.

### **Overall approach**

12. Management have planned Guy Fawkes actions that take into account the risks relating to each Maunga. Management have engaged contractors to ensure, the week prior to Guy Fawkes, all mowing on the Maunga including firebreaks has been completed.
13. The standard Maunga vehicle access hours are 7am – 8.30pm during daylight savings. Dependant on the risk rating of each Maunga, from Tuesday 2 November through to Sunday 7 November vehicle access points will be closed to vehicle traffic earlier than usual to ensure that there are no vehicles present on the Maunga at sunset. Vehicle access will be closed from 7.30pm. Static guards will be based at main entrances from 7.30pm and patrols will take place from 8pm and all pedestrian visitors will be asked to leave the Maunga. Vehicle gates will reopen at the standard time of 7am.
14. Management have engaged an independent security contractor to provision a combination of static entrance security and mobile security patrols, ensuring significant presence throughout the week. There will also be foot patrols operating around the Maunga throughout each evening period.
15. Attachment A sets out a summary of the response actions for each Tūpuna Maunga.

### **Learnings from Guy Fawkes 2020**

16. The operation for Guy Fawkes last year successfully achieved its purpose, with no fires taking place over this period of time, and was a good opportunity for community engagement and education about the significance of the Tūpuna Maunga.
17. Feedback was that for the most part, members of the public were supportive of the initiative to keep the Maunga and its surrounding communities safe. However, the security team did experience confrontational and challenging behaviour from members of the public in some instances.
18. It was noted that some Maunga required a bigger security presence due to the numbers of people wanting to access the Maunga and the nature of entry points on to the Maunga.

In particular, the security presence was bolstered at Maungarei and Ōhūiarangi. These additional requirements have been factored into the planning for this year.

### **Volunteers and Covid 19 considerations**

19. Management continues to consider options for working with volunteers as Tāmaki Makaurau progresses through the various Covid-19 Alert levels.
20. If Tāmaki Makaurau is in Alert Level 3 or 4 during this period, security presence will continue to be on site with strict requirements around distancing, travel to and from site and the use of personal protective equipment such as masks. Management will review Covid-19 management plans to ensure that any work meets Government Covid-19 requirements.

### **Public Communications**

21. Signage advising of the Guy Fawkes week closures, along with the usual 'No Fireworks' signage, will be established at all Maunga entrances during the week commencing 11 October to give visitors advance warning.
22. A letter will be mail dropped to residents bordering the Maunga advising of the closures. Also to be included is an update on fire breaks which will be mown around the Maunga perimeters in the lead up to Guy Fawkes week.
23. Public statements will be widely released on various platforms in the week commencing 25 October to highlight the Maunga closures and the reasons for them. This date is optimal to help with exposure of our messaging as people prepare to purchase their fireworks and plan their Guy Fawkes week.

## Tūpuna Maunga planting update

<b>Purpose</b>	To update the Tūpuna Maunga Authority on the 2021 restoration planting programme.
<b>Recommendations</b>	That the Tūpuna Maunga Authority: a) <b>note</b> the report

### Restoration Planting Programme

- As discussed at Hui 64 (31 May, 2021), the ongoing restoration programme of planting native plants continues on Ngā Tūpuna Maunga.
- The COVID-19 L4 Lockdown announcement in early August meant that the final community planting event August 21 on Te Pane a Matāoho/Te Ara Pueru/Māngere Mountain could not be held. This means that the 2,923 plants due to be planted at this event, will instead be planted at a later time when conditions are optimal.
- At the end of this planting season, a total of 37,202 plants were planted across 8 Tūpuna Maunga: Matukutūruru/Wiri Mountain, Maungarei/Mount Wellington, Ōhūiarangi/Pigeon Mountain, Ōtāhuhu/Mount Richmond, Ōwairaka/Te Ahi-kā-a-Rakataura/Mount Albert, Maungawhau/Mount Eden, Pukewīwī/Puketāpapa/Mount Roskill and Te Pane a Matāoho/Te Ara Pueru/Māngere Mountain between May – August 2021.
- These plantings add to the 65,860 plants already planted over the last 2 years (a total of 103,062 plants).

6. The Maunga were planted with appropriate plant species within the guidance of ecosystem type, site suitability and fire retardant and archaeologically appropriate species.
7. For health and safety reasons, there are areas on Maunga where planting was only undertaken using specialist contractors with the right qualifications, PPE and equipment to undertake the work.
8. Community and schools planting dates were best aligned with the Maramataka. Where dates didn't align with the Maramataka, this was due to the limits of contractor availability, schools availability and weekend planting dates.
9. The multi-year planting programme will continue in 2022 and onwards.

### Next steps

10. Continue with the ongoing restoration programme including planting maintenance and reporting
11. Management will engage with nurseries, including those led by Mana Whenua, to supply plants for the 2022 planting season program.
